'Philosophy' is understood as covering ethics, aesthetics, metaphysics, epistemology, logic, political and social philosophy, the philosophies of education, history, language, mind, religion and science. The Institute is not committed to any school or method. Neither is its membership restricted to those with specialist qualifications in philosophy. Contributors are therefore expected to present their views in as non-technical a manner as their subject-matter permits.

MEMBERSHIP. The Institute welcomes as members any who are interested in philosophy. There are centres of the Institute at the University of Newcastle-upon-Tyne, the University College of North Wales and The University of Southern California. In these centres, as well as at the Institute's Headquarters, 14 Gordon Square, London, WC1H OAG, a programme of lectures is arranged each year.

The annual membership subscription to the Institute is £2.50, \$6.50 in the U.S.A. and Canada. This covers the Journal but not the volumes in the Royal Institute of Philosophy Lectures series. Membership is effective from 1st April of any year. Those joining at other times will receive any numbers of the journal which have already appeared in the relevant membership year.

# **EDITORIAL NOTICE**

THE Council of the Royal Institute of Philosophy announces that Professor H. B. Acton has retired from the editorship of *Philosophy*. Mr. Renford Bambrough has been appointed Editor from 1st July, 1972.

Mr. Bambrough is Fellow and Dean of St. John's College, Cambridge, and University Lecturer in Philosophy. He has been a member of the Council and of the Executive Committee of the Royal Institute of Philosophy since 1965. Before holding his present lectureship he was University Lecturer in Classics. He was Stanton Lecturer in the Philosophy of Religion in Cambridge from 1962 to 1965. He has been a Visiting Professor of Philosophy at Cornell University, at the University of California, Berkeley, and at the University of Oregon. He is author of Reason, Truth and God (1969) and editor of The Philosophy of Aristotle (1963), New Essays on Plato and Aristotle (1965), Plato, Popper and Politics (1967) and of Wisdom: Twelve Essays (1973).

Besides 'The Disunity of Plato's Thought' in the present issue, Mr. Bambrough has published two earlier articles in *Philosophy*, ('Plato's Modern Friends and Enemies', April 1962, and 'Principia Metaphysica', April 1964). His other publications include 'Plato's Political Analogies' in Laslett (ed.) *Philosophy*, *Politics and Society*, First Series, 1956; 'Socratic Paradox', *Philosophical Quarterly*, 1960; 'Universals and Family Resemblances', Proceedings of the Aristotelian Society 1960/61; 'Unanswerable Questions' Proceedings of the Aristotelian Society, Supplementary Volume 1966; 'Philosophy, 1898-1945' in Volume XII of the *New Cambridge Modern History*; 'Objectivity and Objects', Proceedings of the Aristotelian Society 1971/72; 'Foundations', *Analysis* 1970; and 'A Proof of the Objectivity of Morals', *American Journal of Jurisprudence*, 1970 and in Cunningham (ed.) *Situationism and the New Morality*.

Mr. Bambrough has broadcast regularly for the B.B.C. since 1951, Besides taking part in many occasional discussions and giving numerous scripted talks he has taken the chair in a number of series of discussions; the Dunford Dialogues in the Third Programme in 1961 and 1962; 'The Uses of Philosophy' in Network Three in 1961 and 'Nature and Human Nature' in Radio 3 in 1971.
