The Afterthoughts presents succinctly, and with wit and verve, the mature reflections on his lifetime's work of one of France's most distinguished historians. Only one volume of Braudel's projected masterwork Material Civilization and Capitalism has as yet been published. From village markets to bourses to a vast economic sector, Braudel traces the evolution of levels of economy and, through them, of Western civilization.
