

CONTRIBUTORS

WILLIAM E. BUCKLER is Professor of English at New York University. For twenty-three years the editor of *The Victorian Newsletter*, he has made numerous contributions to the study of Victorian literature. His most recent book – *The Victorian Imagination: Essays in Aesthetic Exploration* – was published by the New York University Press in October 1980. He is now revising a monograph on *Idylls of the King* and continues to publish critical articles on Carlyle, Tennyson, Arnold, and Hardy.

ALICE CHANDLER, President of the State University College of New Paltz, N.Y., has taught in the English Departments of City College of New York and Hunter, Barnard, and Skidmore Colleges. She is the author of *A Dream of Order: The Medieval Ideal in Nineteenth-Century English Literature* (1970), co-editor of the forthcoming *From Smollet to James: Essays in Honor of Edgar Johnson* and editor of several textbooks.

LINDA GEORGIANNA has been an Assistant Professor in the Department of English and Comparative Literature at the University of California, Irvine, since 1976. She is a medievalist whose work centers on twelfth-century literature and cultural history, and is the author of *The Solitary Self: Individuality in the Ancrene Wisse*.

ROSEMARY JANN is Assistant Professor of English at Rutgers College and is currently at work on a study of history during the Victorian period.

ARTHUR KINCAID was for six years editor of *Browning Society Notes* and is on the Editorial Board of the Ohio University Press Browning edition. He has taught in the universities of Idaho State, Saskatchewan, Erlangen-Nürnberg, Aveiro, and Bristol, primarily as a Shakespeare scholar, and lived for 15 years in Oxford, from which he has a doctorate. His most recent book is an edition of *The History of King Richard III* by Sir George Buck. Currently he is touring the U.S.A. as a Shakespearean actor.

HELENE E. ROBERTS, Curator of Visual Collections, Fine Arts Library, Fogg Art Museum, Harvard University, is the author of several articles on Victorian art and art criticism. She is currently working on the press and the Victorian art world.

W. DAVID SHAW, Professor of English at Victoria College, University of Toronto, is the author of books on Browning and Tennyson. He has written articles on nineteenth-century poetry and fiction, and is currently at work on a study of Victorian poetic theory.

HERBERT SUSSMAN is Professor of English at Northeastern University. He has written on the Pre-Raphaelites and published *Fact into Figure: Typology in Carlyle, Ruskin, and the Pre-Raphaelite Brotherhood.* He is now working on transformations in later Pre-Raphaelite art and on Victorian tales of the future.

BEVERLY TAYLOR, Assistant Professor of English at the University of North Carolina at Chapel Hill, is particularly interested in the uses of legend and myth in Victorian poetry, and is currently completing a book on nineteenth-century Arthurian literature. She has recently published essays on Byron, Shelley, Tennyson, and Arnold and is editing the poetry of Francis Thompson.
