NOTES AND NEWS

SCOLMA NEWS

The annual SCOLMA conference was held at the Brunei Gallery, School of Oriental and African Studies, University of London, on 25th May. The conference was on the theme "Sharing Information – African Perspectives", and included contributions from Mary Materu-Behitsa (Association of African Universities), Javed Iqbal (British Council), and Bridget McBean (European Centre for Development Policy Management). Selected papers from the conference will be published in future editions of *African Research and Documentation*.

As recorded in the last issue of *African Research and Documentation*, Sheila Allcock stepped down as Chair of the Committee of SCOLMA at the AGM in May 2004. Sheila had been Chair since 1999, and has recently retired from her post as Librarian of the International Development Centre.

David Blake, Librarian at the Commonwealth Secretariat, was elected as Chair of the Committee at the AGM. David has been an active member of the Committee for several years, most recently as Secretary. The role of Secretary has now been taken on by Ian Cooke, Deputy Librarian at the Institute of Commonwealth Studies, University of London.

INSTITUTIONS & ORGANISATIONS

The Institute of Commonwealth Studies has received funding for an 18 month project to catalogue donated collections of African Monographs. These include nearly 750 books originally held by the United Africa Company, dating from the 1790s until the 1960s, and covering history, geography and ethnology. More recent donations particularly focus on Southern African politics. The project is expected to start in August 2004.

The virtual International Institute on Gender and HIV/AIDS was launched on the 7th June in Johannesburg. The Institute has been formed as a collaboration between the Atlantic Centre of Excellence for Women's Health, Dalhousie University, Canada, the Social Aspects of HIV/AIDS Research Alliance (SAHARA), and the AIDS and Rights Alliance of Southern Africa (ARASA).

Nancy Spence, Director of the Social Transformation Programmes Division at the Commonwealth Secretariat, described the organisation as an "Institute ... without borders. It will move from region to region, acting as a catalyst in the sharing of knowledge and experience for effective strategies."

The Institute will promote the use of research in developing and implementing national and regional policy. Researchers, policy makers, and Civil Society representatives from five countries (Canada, Lesotho, Botswana, South Africa and Swaziland) were present at the five-day meeting at which the Institute was launched.

AWARDS & PRIZES

Commonwealth Writers Prize

The award for Best Book in the Africa region was won this year by South African author Damon Galgut, for *The Good Doctor*. Diane Awerbuck, also from South Africa, won the Best First Book award for *Gardening at Night*.

The Commonwealth Writers Prize annually awards £1,000 to authors for Best Book and Best First Book in four regions: Africa; the Caribbean and Canada; Eurasia; and South-East Asia and South Pacific. One winner from these regions is awarded £10,000 for Best Book overall. This year the prize was awarded to the Caribbean-born UK author Caryl Phillips for *A Distant Shore*.

Harry Brittain fellowship

Three African journalists were among the ten senior Commonwealth journalists to be awarded the Harry Brittain fellowship for 2004. The fellowship covers a six-week programme in the UK, designed to broaden experience and encourage close international relationships.

Wilton Mamba, editor of Swaziland-based, *The Weekend Observer*, and one of the ten fellows, described the importance of the programme, "as an editor of a small newspaper ... I hope to learn a lot from other newspaper companies, especially small companies the same as my own, on how they run their affairs and the way they operate."

Other fellows included Francis Pabai, Assistant Editor-in-Chief of *The Independent* (Gambia); and Kay Karriem, Assistant Editor of *Huisgenoot Magazine* in South Africa.

The Harry Brittain Fellowship is named after the founder of the Commonwealth Press Union, and is awarded annually by that body to up to twelve journalists, aged between 28 and 38, and fully employed by a member newspaper. Enquiries about the 2005 Fellowship are invited from October 2004.

Coutts Nijhoff International West European Specialist Study Grant Helene Baumann, African and Western European studies librarian at Duke University, has been awarded the Specialist Study Grant. The grant covers the costs of travel to, and accommodation in, Europe. Helene will travel to Europe to translate the subject thesaurus of the Pictorial Archive of the German Colonial Society (Bildarchiv der Deutschen Kolonialgesellschaft).

PUBLISHING & THE BOOKTRADE

Oneworldbooks

Launched in June 2004, Oneworldbooks is an online bookstore, specialising in subject areas such as HIV/AIDS, law, politics and development. It holds titles from African and International publishers, including the Nordic Africa Institute, the South African Institute of International Affairs, and the Institute for Democracy in Africa.

Turning Points

A new history book series was launched by the South African Department of Education to celebrate 10 years of education reform. The series, *Turning Points*, is an initiative of the Institute for Justice and Reconciliation, and aims to portray an African view of South Africa's history. High schools throughout the country will each receive eight volumes from the series.

ON FILM

The third Commonwealth Film Festival was held in Manchester, UK, from 30th April to 9th May 2004. The festival saw a number of screenings of documentaries and other films from Africa. Interest in South African filmmaking was high, and one of the highlights of the festival was the UK premier of Ntshaveni Wa Luruli's *The Wooden Camera*. The winner of "Best Feature Film for a Young Generation" at the 2004 Berlin International Film Festival, *The Wooden Camera* examines interracial tension, social injustice, and growing up in a South African township.

Roots Calling, a documentary about the return to South Africa of musicians who had fled to the United Kingdom during apartheid, received its international premiere at the festival.

Films from elsewhere in Africa were also well-represented, with an introduction to Nigerian Cinema; documentaries on political problems in Zimbabwe and AIDS orphans in Kenya and Malawi; and a showing of Jason Xenopoulos' *Critical Assignment*, described as the first ever high-budget pan-African action movie.

ONLINE

Swahili Manuscripts Database http://www.swahilimanuscripts.soas.ac.uk/ Online catalogue for the collections of Swahili manuscripts held at the School of Oriental and African Studies Library. This represents some 250 items (the largest collection of its kind in Britain), in Arabic and Roman script, and ranging in date from the 1790's to 1970's. The manuscripts include letters, essays on history, stories, and secular and religious poetry.

The collections represent a rich source for the study of Swahili language and thought, and provide examples of regional dialects and the use of Arabic script in Swahili. A number of texts in Arabic script have been reproduced digitally, and may be accessed from the website. For each digitised text, it is possible also to hear a recording of a recital of the text by Shaikh Yahya Ali Omar, one of few leading scholars in the reading of such manuscripts.

To coincide with the launch of this database, Adam Matthew Publications will be publishing a microfilm copy of nearly 100 of the manuscripts. See the entry under "Reference Sources, Bibliographies and Information Work" for further details.

Nuer Field Notes http://www.dlib.indiana.edu/collections/nuer/ Digitised field notes on the Nuer language compiled by Eleanor Vandervort, a former missionary to South Sudan. Project funded by the Indiana University African Studies Program, and carried out by Marion Frank-Wilson (librarian for African Studies at IU), Edward Miner (International Studies Bibliographer, University of Iowa) and Indiana University's Digital Library Program.

The site contains images of Eleanor's notes, a database of transcriptions from the notes, letters, and slides.

South Africa's Struggle for Democracy: Anti-Apartheid Periodicals 1960-1994 http://disa.nu.ac.za/

A selection of forty South African periodicals have been digitised by the Digital Imaging of South Africa (DISA) project, with funding from the Andrew Mellon Foundation. The full text is available for research purposes. The content, publication and distribution methods of these titles meant that few libraries were able to keep entire runs (if at all) of many of these periodicals. The project makes an important contribution to research in this area by bringing together entire, or near-complete, collections. The periodicals can be browsed by title, and subject and personality indices are being compiled. A second phase of the project will add more digital content.

Internet Mission Photography Archive (IMPA)

http://library.usc.edu/uhtbin/catstat.pl/impa

Hosted by the University of Southern California. This is a database containing images from mission photograph collections held in Europe and North America. Coverage dates from the 19th century to World War II, and includes Asia, the Pacific and the Caribbean, as well as photographs from Africa. The collection is growing, but currently numbers more than 2,000 images. Comments and suggestions about the project may be sent to Jon Miller, the Project Leader, at jonmill@usc.edu .

African Journals Online (AJOL) http://www.ajol.info

African Journals Online has been re-launched at the new online address. Registration and use of the database is free. Search results include links to abstracts and online locations of articles, where available, and there is a document delivery service for obtaining the full text of articles. The latter is a charged service, with proceeds being paid back to participating journals. The database now covers more than 175 journal titles published in Africa. Subject areas include: agricultural science, health, humanities, social sciences, and arts.

Since its launch in 1998, AJOL has proven to be a much valued tool for both researchers interested in Africa and publishers of journals based in Africa. Nearly 4,000 people registered to use the database in 2003. An evaluation of the service, carried out in 2002, demonstrated that publishers benefited from increased international submissions and citations.

Nigerianet http://www.nigerianet.org

Nigerianet is an online information and networking portal designed for civil society and donor agencies working in and around the field of human rights in Nigeria. The website contains a directory of organisations in Nigeria; a learning resources section aimed at capacity building for Civil Society organisations; and news and job listings. It also contains an area for registered members, which allows access to discussion fora and a facility for organisations to create their own work area.

Nigerianet is a British Council Nigeria project, supported by the European Commission, and was launched in December 2003.

ICTs for Intercultural Dialogue – A UNESCO Project for Indigenous People Launched in February 2004, the project will work to improve access to and develop skills in ICTs for Indigenous People. The aim is to encourage the preservation of cultural resources, and to support the creation of new resources, through use of new media. The project will involve ten communities, including the Pygmies and Himbas in Africa.

African Renaissance

Bi-monthly, launched in June 2004 from Adonis-Abbey publishers. This title intends to mix academic and "higher end" news and features. Its editorial policy is to take articles and features on any topic of relevance to Africa, but with particular application to policy making and policy makers. The journal aims to be "non-ideological and non-sectarian". The first issue focused on historical and contemporary Arab-African relations, recent economic development in Nigeria, and politics in South Africa and Zimbabwe.
