Opportunities to Influence the Content of the Proposed OSHA TB Standard

Many readers are aware that OSHA has extended the deadline for written comments and notices of intent to appear at the scheduled public hearings until February 17, 1998, with a deadline for testimony and documentary evidence of February 27. Public hearings will begin in Washington, DC, on April 7; additional hearings are scheduled tentatively to take place in Los Angeles, beginning on May 5, Chicago on May 19, and New York City on June 2.

Issues related to the frequency of TB skin testing for healthcare workers, training, fit checking and fit testing, and distinctions between workplace-related and -unrelated TB illness already have been raised in the AHA's letter to OSHA, copies of which may be obtained electronically from Gina Pugliese (gpugliese@aol.com). OSHA's method of evaluating their guideline is weighted by the volume of responses received. Readers are encouraged not only

to communicate their concerns with regard to the proposed standard to SHEA's response coordinator, Michael Tapper, MD (mltappermd@aol.com), but also to respond directly to OSHA.
