International Lead Production and Trade in the "Age of the Saigerprozess" 1460-1560

The old medieval silver industry was in the 1450s all but moribund. In its place a new one emerged within which producers exploited a new resource base of polymetallic ores - argentiferous copper, tin, cobalt, nickle, bismuth - by means of new technologies including, in the working of silver bearing copper the **Saigerprocess**, the following decades witnessing the beginnings of a new central European industrial long-cycle as production steadily increased, rising rapidly to ca. 120.000 marks in 1477 and then more slowly to ca. 180.000 marks in 1540. For a century European silver production was dominated by new industry employing new techniques. It is the story of these fundamental changes in the production and distribution of lead this book is dedicated to.

- 1. Articles should be between 4000 and 9000 words. Authors should submit one copy of the article (with an indication of length in words) plus an abstract of no more than 100 words to *each* of the Editors. Comments on previously published articles will also be considered, provided they do not exceed 1500 words.
- Manuscripts should be typed in double spacing throughout on one side of the paper only, with generous margins.
- 3. Endnotes should be numbered consecutively through the manuscript and typed *in double spacing* on separate pages at the end.
- 4. Maps and graphs (figures) and tables should be submitted on separate pages. Figures should be submitted in rough draft. However when a submission has been accepted for publication, authors are responsible for providing camera-ready versions. Figures and tables should be numbered consecutively in arabic numerals. A separate, double-spaced list of figure captions should be provided.
- 5. British conventions for spelling and punctuation are followed and single inverted commas used except for quotations within quotations which use double.
- 6. Bibliographical references should be given in full in the endnotes when first cited; thereafter use author surname and short title. The detailed notes referred to above should be carefully observed.
- 7. Contributors should keep one copy of the typescript for correcting proofs. First proofs may be read by contributors provided that they can give the Editors an address through which they can be reached without delay and can guarantee to return the corrected proofs to the designated Editor, by airmail where necessary, within three days of receiving them. Corrections should normally be restricted to printer's errors.
- 8. Contributors of accepted articles will be asked to assign their copyright, on certain conditions, to Cambridge University Press to help protect their material.
