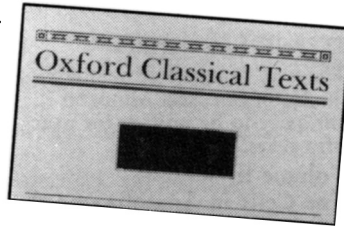
Oxford Classical Texts

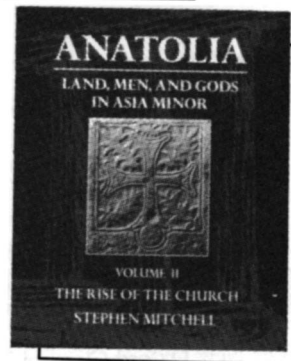
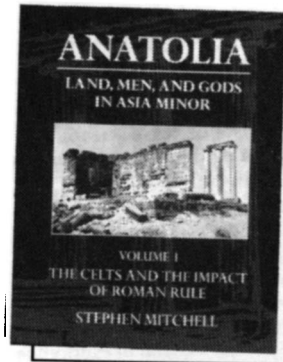

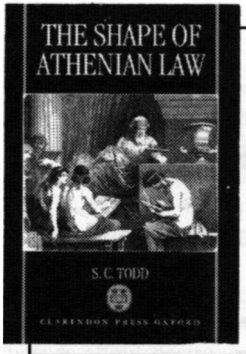
