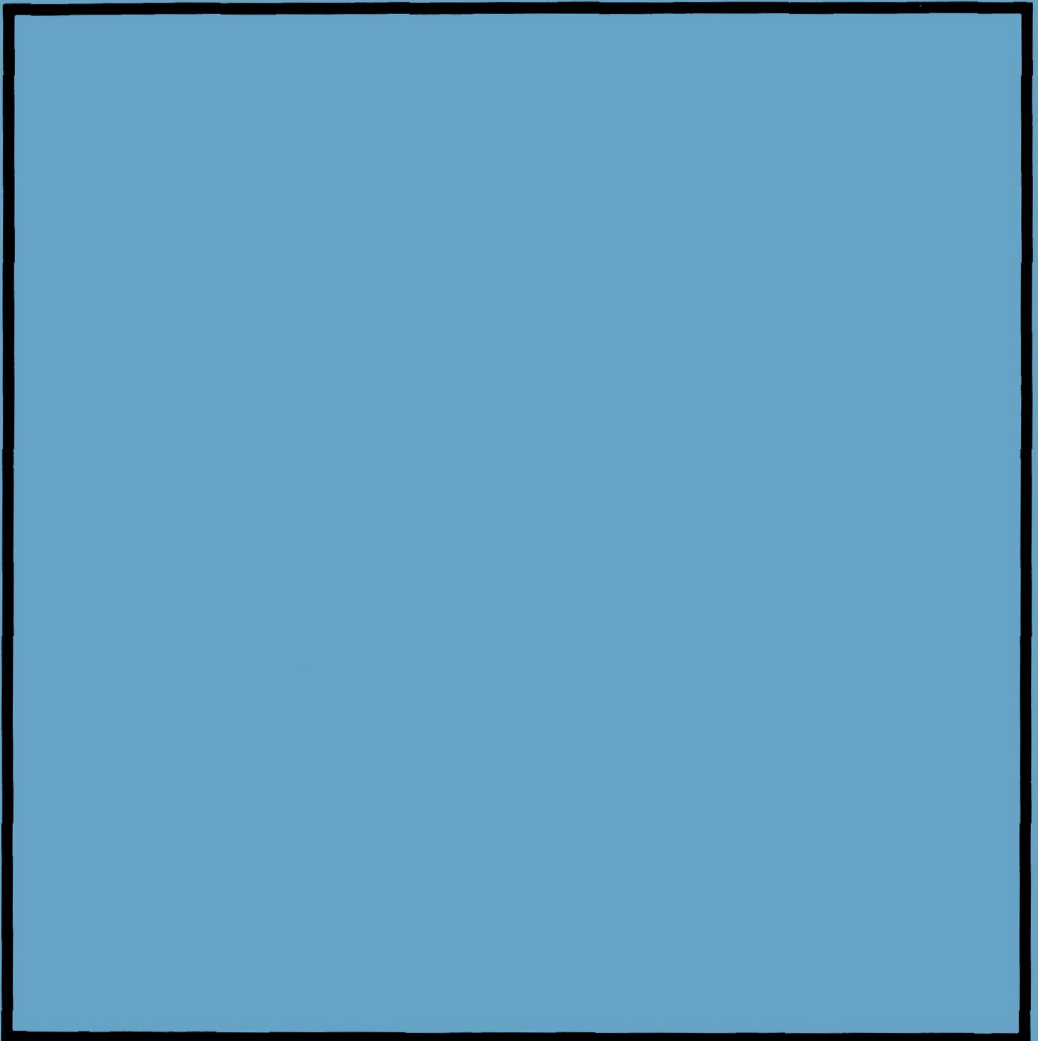

Manuscripts will be submitted without the name of the author to outside readers; please include a removable cover page giving title, authorship, affiliation, and address; the article itself should carry only the title. The *Review* will only consider manuscripts that have not been published elsewhere and are not being considered by other journals.

Samatar traces the transformation of Somali society from the late 19th century to the present. He argues persuasively that the processes of colonization, commercialization, and the creation and expansion of the bureaucratic state in Somalia during the twentieth century have created an underdeveloped rural economy.

Samatar's analysis of the development and investment programs of the modern Somali state demonstrates the almost total neglect of the productive sectors of the economy dominated by peasants and pastoralists.

A Working Class in the Making Belgian Colonial Labor Policy, Private Enterprise, and the African Mineworker, 1907-1951

For colonial administrators and the Belgian banks, the Belgian Congo was an immensely rich source of raw materials: diamonds, gold, manganese, oils, nuts, tobacco, peanuts, etc. One of the major forms of exploitation of the Congo was the effort to set up mining companies and to force Africans to work in the mines to extract these resources. Focusing on the most powerful of these mining companies—the Union Minière du Haut-Katanga, John Higginson provides a detailed history of the relationship between the company and the African workers from 1907 through 1951.
