# Accelerated Development in Sub-Saharan Africa

### An Agenda for Action

This report has been prepared by the staff of the World Bank. It highlights the severity and complexity of the problems facing many of the countries of Sub-Saharan Africa in their efforts to raise the living standards of their people.

The central theme of the report is that more efficient use of scarce resources – human and capital, managerial and technical, domestic and foreign – is essential for improving economic conditions in most African countries. From this flow a number of suggestions for the improvement of incentives and institutional support for production, particularly in agriculture.

The report offers no general prescriptions, but aims to encourage the reviews and discussions which are prerequisite to the formulation of the programmes of action which must be formulated by each country.
