

NOTES ON CONTRIBUTORS

Ángel Alcalde is Lecturer in History at the University of Melbourne, Australia. He holds a PhD from the European University Institute (Florence, Italy). He has been an Alexander von Humboldt postdoctoral fellow at LMU Munich (Germany) and a Research Fellow at the Centre for the History of Global Development at Shanghai University (China). He is a specialist in the social and cultural history of warfare, transnational history and the history of fascism. He has published widely on the Spanish Civil War and Franco's dictatorship, including a book on Francoist ex-combatants, *Los excombatientes franquistas* (PUZ, 2014). His latest monograph, *War Veterans and Fascism in Interwar Europe*, was published with Cambridge University Press in 2017. His most recent work has focused on war veterans' international organisations and his current research projects examine the relationship between war and globalisation and war and genocide, as well as sexual violence in war and authoritarian regimes.

Udi Greenberg is Associate Professor of History at Dartmouth College. He is the author of the prize-winning *The Weimar Century: German Émigrés and the Ideological Foundations of the Cold War* (Princeton, 2015), as well as many articles and essays on European politics, religion and thought. He is currently working on a book length project that explores the revolutionary end of Catholic–Protestant animosities in the twentieth century.

Kevin Tallec Marston is Research Fellow at CIES and a Visiting Researcher and Lecturer at the International Centre for Sports History and Culture at De Montfort University, Leicester, where he completed his PhD in history. His work has focused on the history of youth football, the question of age, the place of childhood in society, the evolving role of training and education of youth in and around sport and the biography of sporting administrators as well as other themes such as legacy, diffusion, fraternity and transnationalism. He also has a particular interest in the questions of governance in sport, specifically the historical, political and economic aspects of both European football and its main governing body UEFA, as well as the global game and FIFA. He is a member of the *Réseau d'études des relations internationales sportives* (RERIS) (www.reris.net).

Arie L. Molendijk is Professor of the History of Christianity and Philosophy at the University of Groningen. He has published extensively on the history of ideas, in particular on nineteenth- and twentieth-century theology, religious studies and philosophy. Among his writings are a German-language book on the theologian and sociologist Ernst Troeltsch and a monograph *The Emergence of the Science of Religion in the Netherlands* (Brill, 2005). Molendijk is also engaged in research on religion, identity and the public sphere, which led to a co-edited volume *Exploring the Postsecular. The Religious, the Political and the Urban* (Brill, 2010). He has also participated in a research programme on new sacred places and emerging rituals, which resulted in two co-edited volumes *Holy Ground: Re-inventing Ritual Space in Modern Western Culture* (Peeters, 2010) and *Sacred Places in Modern Western Culture* (Peeters, 2011). His latest book is *Friedrich Max Müller and the Sacred Books of the East* (Oxford University Press, 2016).

Justine Buck Quijada is the author of *Shamans, Lamas and Soviets: Rituals of History in Post-Soviet Buryatia* (Oxford University Press, 2019), which examines religious rituals as sites for producing historical knowledge in the post-Soviet period. She also co-edited *Atheist*

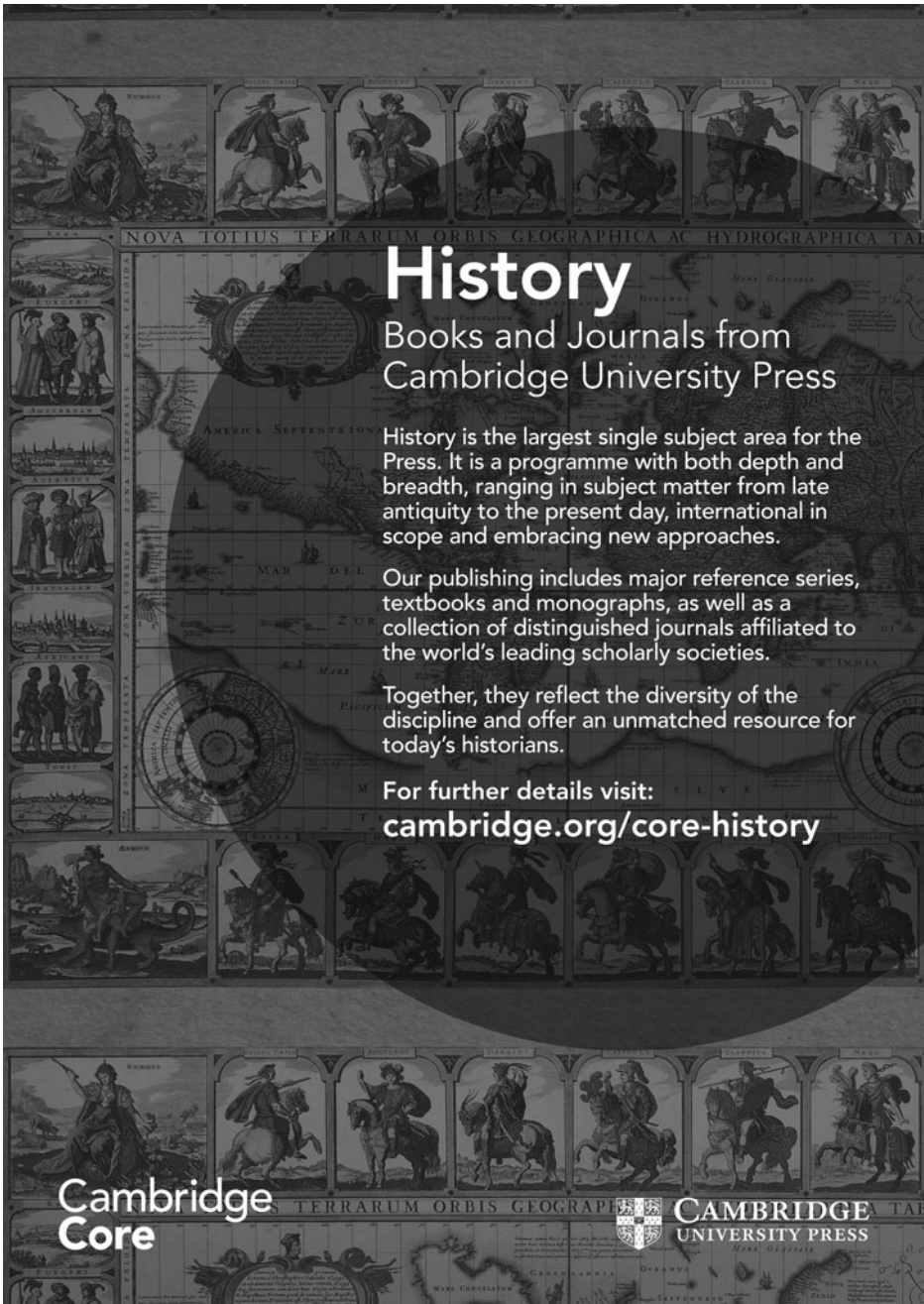
Secularism and its Discontents: A Comparative Study of Religion and Communism in Eurasia (with Tam T. T. Ngo, Palgrave Macmillan, 2015). Her on-going research focuses on urban shamanism in Buryatia, Soviet secularism and the intersections between the global New Age and indigenous religious practices.

Mark Edward Ruff is Professor of History at Saint Louis University. He was trained in both American and European history at Brown University with a focus on religious history, the history of Catholicism and secularisation. He is the co-editor of two books, the author of two monographs and the co-editor of two forthcoming edited volumes. His most recent book, *The Battle for the Catholic Past in Germany, 1945–1980* was published in 2017 by Cambridge University Press and focuses on the culture wars surrounding the Catholic Church's role during the Third Reich. He is beginning work on a project involving political polarisation and allegations of guilt for the First World War in 1920s and 1930s Germany.

Heléna Tóth teaches modern European history at the Otto-Friedrich-University, Bamberg. After completing her dissertation on the history of political exile (Harvard University, 2008), she worked at Boston University and the Ludwig-Maximilians-University as Lecturer and Research Fellow. She has published widely on the history of political exile in the nineteenth century and the cultural history of socialism. She is author of *An Exiled Generation: German and Hungarian Refugees of Revolution, 1848–1871* (Cambridge University Press, 2014), co-editor with Katrina Gulliver of *Cityscapes in History, Creating the Urban Experience* (Ashgate, 2014) and co-editor with Charlotte Lerg of *Transatlantic Revolutionary Cultures* (Brill, 2017). She has published articles and book chapters on the history of name giving ceremonies and funerals in state socialism. She is currently working on a book project on secular rites of passage in East Germany and Hungary, 1949–89.

Philippe Vonnard holds a PhD in Sport Sciences and Physical Education from the University of Lausanne, where he is SNSF Senior Research Fellow (on the project '*La fabrique des sports nationaux*'). He specialises in the history of the internationalisation of sports. He has already published several articles on this topic and has notably coordinated *Building Europe with the Ball* (Peter Lang, 2016) and *Beyond Boycotts: Sport during the Cold War in Europe* (De Gruyter, 2017), as well as authoring *L'Europe dans le monde du football. Genèse et formation de l'UEFA* (Peter Lang, 2018). He is a member of the *Réseau d'études des relations internationales sportives* (RERIS) (www.reris.net) and co-editor of the series 'Transnational Sport History' (De Gruyter).

Todd H. Weir is Professor of History of Christianity and Modern Culture in the Faculty of Theology and Religious Studies of the University of Groningen. Prior to arriving in the Netherlands, he taught at Queen's University Belfast for nine years. He is the author of *Secularism and Religion in Nineteenth-Century Germany: The Rise of the Fourth Confession* (Cambridge, 2014) which won the Jacques Barzun Prize for Culture History.

INSTRUCTIONS FOR CONTRIBUTORS

Contemporary European History covers the history of Eastern and Western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Authors wishing to submit articles for publication should do so through the journal's online submissions system at <http://mc.manuscriptcentral.com/conteurohistory>.

Articles should normally be about 8,000 words long, not including footnotes. Review articles should not exceed 6,000 words, including footnotes. The journal also considers special issue proposals. Please contact the editors for details.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

Submission of an article will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of an article, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction.
