W. MARVIN WILL, *Associate Professor at the University of Tulsa, is past president of the Midwest Association of Latin American Studies (MALAS) as well as a founding member and past board member of the Caribbean Studies Association (CSA). The author of numerous articles, he coauthored The Caribbean in the Pacific Century (forthcoming from Lynne Rienner Press) and coedited The Restless Caribbean.*

MICHAEL W. FOLEY *is Assistant Professor of Politics at the Catholic University of America in Washington D.C. He has written on peasant mobilization and is currently studying the impact of neoliberal reform in Mexico, Chile, and Costa Rica on peasant and grower organizations.*

SUSAN STOKES *is Assistant Professor of Political Science at the University of Chicago. She has written on urban social movements and class and ethnicity in Peru. She is currently researching alternative models for development with democracy in Latin America.*

BEVERLY NAGEL *is Associate Professor and Chair of the Department of Sociology and Anthropology at Carleton College. She also directs the college's program in Latin American Studies. Her article is based on material collected as part of an ongoing study of colonization and ethnic relations in Paraguay's eastern border zone.*

PETER RANIS *is Professor of Political Science at York College and the Graduate School and University Center of the City University of New York. He has written extensively on Argentina and has published numerous articles on Argentine workers.*

A consultant to the World Bank and the U.S. Library of Congress, he has written several recent studies of Brazilian economic policy.*

PETER S. CLEAVES *is Director of the Institute of Latin American Studies at the University of Texas at Austin. Previously affiliated with First Chicago and the Ford Foundation, he has written several books on Mexico, Peru, and Chile.*

CHARLES J. STEPHENS *most recently served as a media fellow at the Hoover Institution. Formerly Executive Vice President of General Products, S.A. in Mexico City, he has been a regular political columnist for The News (Mexico City) and has taught at the University of the Americas in Mexico City.*

GEORGE A. ANDRES AVELLANEDA teaches Latin American literature at the University of Florida. His research focuses on the sociology of literature, ideology, and literary theory and criticism. He is the author of *El habla de la ideología: modos de réplica literaria en la Argentina contemporánea and Censura, autoritarismo y cultura: Argentina, 1960–1983.*

The academic interests of **WARD A. STAVIG** focus on Indians in Mesoamerica and the Andes, especially during the colonial period. His dissertation deals with Indian communities of rural Cuzco in the era of Thupa Amaro, and his work stresses the importance of ethnicity and culture in the lives of native peoples.

KENNETH J. MIJESKI is Chairman and Professor of Political Science at East Tennessee State University. His writings include essays on the Costa Rican presidency and Latin American relations with the United States as well as a textbook coauthored with Steven W. Hughes, *Politics and Public Policy in Latin America.* He is currently editing a book on the 1987 Nicaraguan constitution, to be published by Ohio University Press.

KEVIN J. MIDDLEBROOK is Assistant Professor of Political Science at Indiana University in Bloomington. During 1990–91, he is a visiting research fellow at the Center for U.S.–Mexican Studies, University of California, San Diego. The author of extensive work on state-labor relations, Mexican politics, and U.S. policy toward Latin America, he is completing a book on organized labor and the state in postrevolutionary Mexico.
