Yugoslavia was the first Communist-ruled state to defy Soviet domination. It was also the first state to deviate from the Soviet model by experimenting with a "socialist market economy," de-centralized decision-making and "social self-management," novel forms of political participation, and open frontiers.

This is a study of the people, the ideas, the political and economic constraints, and the dynamics of social change and of institutional manipulation that have shaped the Yugoslav experiment—from the agony and the dilemmas that confronted Tito and his associates after Stalin denounced them in 1948 to the Constitution and Party Congress that marked the beginning of a new chapter in 1974.
