**Philip C. C. Huang.** The author integrates three major traditions of peasant studies and uses vast quantities of new materials to present a convincing interpretation of the origins and nature of the agrarian crisis that gripped the North China Plain in the two centuries before the Revolution. Through a comparison of the histories of small family farms and larger scale managerial farms, the author documents and illustrates the long-term trends of agricultural commercialization, social differentiation, and mounting population pressure. He shows how those changes combined to produce, within the small peasant economy, a noncapitalizing managerial elite and a partially proletarianized peasantry, a pattern of change different from and more volatile than the development in Western Europe of a capitalizing elite and a proletarianizing peasantry. \$37.50

## Family and Population in East Asian History

Edited by Susan B. Hanley and Arthur P. Wolf. The 13 papers in this volume represent a concerted effort to place the historical demography of East Asia on a firm quantitative basis. They explore a wide range of Chinese and Japanese documentary sources and raise new and substantial questions about both family history and population change. The most important finding is that when viewed from a demographic perspective, China and Japan are seen to be fundamentally different societies, refuting Malthus's argument that "the state of Japan resembles in so many respects that of China, that a particular consideration of it would lead into many repititions." What makes this particularly intriguing is that the difference between these two Asian civilizations is shown to be similar to the difference between Western Europe and Eastern Europe. **Fernando Galbiati.** The story of P'eng P'ai (1896–1929), founder and guiding spirit of China's first Communist enclave, shows that an organized peasantry and the Chinese Communist Party were linked as early as the 1920's.
