Contributors

Michael R. Adamson is adjunct professor of history at California State University, Sacramento, and an independent historical consultant. His numerous essays on business, policy, and urban history have appeared in *American Sociological Review*, *Diplomatic History*, *Financial History Review*, *Journal of American–East Asian Relations*, *Journal of Urban History*, *Presidential Studies Quarterly*, and this journal.

Marcelo Bucheli is assistant professor of international business and history at the University of Illinois (Urbana-Champaign) and a fellow at the University of Illinois Center for Advanced Study. His article “Canadian Multinational Corporations and Economic Nationalism,” in *Entreprises et Histoire* (2009), received the Petroleum History Institute Article of the Year Award. He has published other articles on the history of the oil industry and a book on the banana industry.

Lisa Bud-Frierman is visiting research fellow at the Centre for International Business History, University of Reading, in the United Kingdom, and editor of *Information Acumen: The Understanding and Use of Knowledge in Modern Business* (1994). She is completing a publication on the collection of agricultural statistics in nineteenth-century Britain.

Nathan J. Citino is associate professor of history at Colorado State University. His book, *From Arab Nationalism to OPEC: Eisenhower, King Sa‘ud, and the Making of U.S.–Saudi Relations*, was just published in a second edition by Indiana University Press. Other writings have appeared in *Diplomatic History*, *Diplomacy & Statecraft*, *Arab Studies Journal*, and *International Journal of Middle East Studies*.

Andrew Godley is professor of management and director of research at the Centre for Entrepreneurship at the Henley Business School, University of Reading. He has written widely on the history of entrepreneurship, international business, and business culture.

Diana Davids Hinton, coauthor with Roger M. Olien of six books on the history of the American petroleum industry, is professor of history at the University of Texas of the Permian Basin, where she holds the J. Conrad Dunagan Chair of Regional and Business History.

Daniele Pozzi is research fellow in the Department of Institutional Analysis and Public Management at Bocconi University in Milan. He also holds a yearly appointment as lecturer in economic history at LIUC University in Castellanza. He has written several articles, mainly on the Italian oil business. His book on this subject was published in 2009.

Keetie Sluyterman is professor of business history at Utrecht University in the Netherlands. She has written, or jointly authored, a large number of business histories, including histories of Océ, Proost en Brandt, CSM, (Moret) Ernst & Young, Rabobank, Hagemeyer, and Royal Dutch Shell. Her book *Dutch Enterprise in the Twentieth Century: Business Strategies in a Small Open Economy* was published in 2005.

Judith Wale is fellow of the Institute of Chartered Accountants in England and Wales and a visiting research fellow at the CIBH, University of Reading. She was a lecturer in accounting at Warwick University Business School, and she has written about the history of trading companies (with Geoffrey Jones) and bank–industry relations (with Michael Collins and Forrest Capie).
