### Tuberculosis Issues

Until December 13, 1993, members of SHEA have the opportunity to respond, as individuals, to the Centers for Disease Control and Prevention (CDC) with respect to the "Draft Guidelines for Preventing the Transmission of Tuberculosis in Health Care Facilities, Second Edition," which were published in the *Federal Register* on October 12. Once finalized, these guidelines will be used by OSHA to guide their TB protection enforcement activities (see below). Thus, it is of

great importance that members comment directly to CDC, within the comment period, regarding elements of the guidelines that might deserve revision or reconsideration.

On October 8, nearly concomitant with the publication of the CDC draft revised guidelines, the director of compliance programs for OSHA sent a memorandum to all regional OSHA administrators setting forth enforcement policies and procedures for occupational exposure to

tuberculosis (see page 694 in this issue). In this document, OSHA states that "employers must provide and ensure the use of high-efficiency particulate air (HEPA) respirators as the minimum acceptable level of respiratory protection." Those who have not already seen the OSHA or *Federal Register* documents will want to review all of the detail that is included. The window of opportunity for comment to the CDC will close soon.

### SHEA Sets Annual Meetings for 1998 and 1999
