Amongst the forerunners of the Vienna Circle, Ernst Mach (1838-1916) is one of the most important. He may be regarded as an early proponent of the verifiability principle later central to the Vienna Circle (whose official name was: Verein Ernst Mach): no statement can be accounted scientific unless it is empirically verifiable.

The present volume is based on a set of lectures given in 1895-96 together with some later essays, and was published by the author in 1905. It contains pieces on various topics in the history and philosophy of science and suggestions concerning the theory of knowledge.

The establishment of the DeGolyer Collection in the History of Science and Technology in 1949 saw the start of a remarkable collection of scientific monographs and journals. Including works in all languages from the beginning of printing, the holding is now world-famous for its comprehensiveness and many rare items.

This dictionary catalogue, which reproduces the Libraries' card catalogue, contains over 39,000 entries describing 50,000 separate volumes. Main entries usually appear under author, but there are also subject entries for works on individuals and cross-references for variant forms of names. Cataloguing follows procedures accepted by the American Library Association and the Library of Congress.
