NOTES ON THE CONTRIBUTORS

DAVID WILLIAM FOSTER is Professor of Spanish at Arizona State University and Chair of the Publications Committee of the Center for Latin American Studies. He is the editor of A Handbook on Latin American Literature and is currently preparing a registry of Jewish culture in Argentina with Naomi Lindstrom.

WINIFRED CREAMER received her Ph.D. from Tulane University in 1983. She has conducted field research in Central America for the past ten years. Her current research focuses on prehistoric ethnic groups and interregional boundaries between Central American and non-Central American groups.

TERRY LYNN KARL is Assistant Professor of Political Science at Stanford University. She has written extensively on problems of peace and democratization in Central America and is currently working on a book about the impact of oil booms on oil-exporting states, especially Venezuela.

JEFFRY A. FRIEDEN is Assistant Professor of Political Science at the University of California, Los Angeles. He has written on the politics of international monetary and financial relations, economic policy, and Third World debt. Since 1982 he has spent nearly eighteen months in Latin America researching the politics and economics of the region's international financial relations from 1965 to the present.

WILLIAM D. STANLEY is a Ph.D. candidate in Political Science at the Massachusetts Institute of Technology. He is currently studying the politics and consequences of human rights violations in Central America.

JOHN M. LIPSKI is Associate Professor of Spanish Linguistics at the University of Houston. His research interests include Hispanic dialectology, creole studies, and the theory of bilingualism. He has conducted extensive fieldwork in Latin America, Africa, and Asia.

WILLIAM C. THIESENHUSEN conducts research on land reform and rural development at the Land Tenure Center and teaches courses on economic development in the Department of Agricultural Economics at the University of Wisconsin–Madison. He is Professor of Agricultural Economics.

MARK T. GILDERHUS, Professor of History, chairs the Department of History at Colorado State University. He specializes in the history of foreign relations between the United States and Latin American countries. He is the author of numerous articles, Diplomacy and Revolution: U.S.-Mexican Relations under Wilson and Carranza, and the forthcoming Pan American Visions: Woodrow Wilson and Regional Integration in Latin America, 1913–1921, to be published by the University of Arizona Press.

GRANT T. JONES is Professor of Anthropology and Chair of the Department of Anthropology and Sociology at Davidson College. In addition to his ethnographic research in Belize, he has edited Anthropology and History in Yucatán and has published various articles on lowland Maya ethnohistory. He is

currently working on a study of Maya-Spanish relations on the sixteenth- and seventeenth-century frontiers of southeastern Yucatán.

DIEGO ABENTE, Assistant Professor of Political Science at Miami University, has published essays on the politics of Venezuela and Paraguay. He is currently preparing a comparative analysis of Latin American democracies.

ROY ARTHUR GLASGOW, currently Associate Professor of History at Boston University, has taught at Morgan State University and the Universidade Fluminense Federal in Niterói, Rio de Janeiro. He is the author of Guyana: Race and Politics among Africans and East Indians and Nzinga: Resistência Africana a Investida do Colonialismo Português em Angola and coeditor of the forthcoming book The Troubled and Troubling Caribbean.
