Referrals are made upon the request of a member or of an institution.

## **Toward a Democracy**

### **A BRIEF INTRODUCTION TO AMERICAN GOVERNMENT**

LOUIS W. KOENIG, *New York University*

Intended for the introductory government course, *Toward A Democracy* is an issues-oriented paperback textbook that analyzes both the institutions and processes of American government, focusing on where the achievements of democracy fall short of its ideals—and what can be done about it. The book uses examples and anecdotes drawn from contemporary issues to illustrate where the system is currently breaking down or improving; a section at the end of each chapter discusses specific proposals to make the system function more effectively. 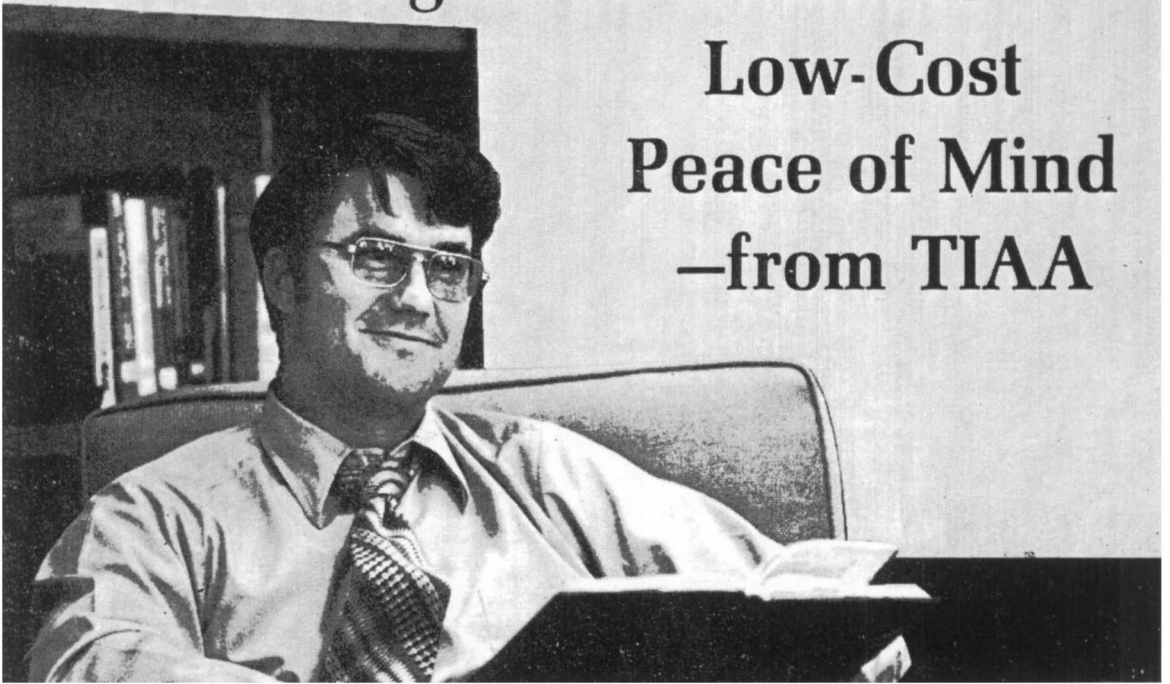

# Modern Ideologies
