The 17 essays in this book present a sample of new work demonstrating the strengths and uses of the Harris Matrix, the first ever published collection of papers devoted solely to stratigraphy in archaeology. The crucial relationships between the Harris method, open-area excavation techniques, the interpretation of interfaces, and the use of singlecontext plans and recording sheets are clarified by references to specific archaeological sites. These sites range from medieval Europe through Mayan civilizations to Colonial Williamsburg, Virginia. This book, a great value to anyone involved in excavating and recording, will ensure that the maximum amount of stratigraphic information is gathered during future archaeological investigations.

Principles of Archaeological Stratigraphy Second Edition

Edward C. Harris with a Foreword by Michael B. Schiffer

This important work provides the fundamentals for most studies in archaeology. The book, first published in 1979, resulted from its author's invention of the Harris Matrix—a method for analyzing and presenting the stratigraphic sequences of archaeological sites. This method is now widely practiced in archaeology worldwide.

The opening chapters of the Second Edition discuss the historical development of archaeological stratigraphy. Central chapters examine laws and basic concepts, and the remaining chapters review methods of recording stratification, constructing stratigraphic sequences, and analyzing stratification and artifacts. The final chapter outlines the modern system for recording stratification on archaeological sites.

Complete with a glossary of stratigraphic terms, this edition is written in a style suitable for students or amateur archaeologists. Even professional archaeologists will gain food for thought from this book's radical ideas.

Prehistoric Subsistence on the Southern New England Coast

The Record from Narragansett Bay David J. Bernstein

This book examines long-term trends in prehistoric subsistence in the Narragansett Bay region of Southern New England. The results suggest that, unlike other areas of Eastern North America, specialized agricultural economies did not develop in this region prior to European contact. It also suggests that subsistence intensification was achieved through diversification and cultural modification of the landscape. This book incorporates specific observations and raw data in easy-to-use appendices. It also reviews results and features in usable summary tables and figures. As such, the book is accessible to both the general reader as well as scholars and students interested in consulting the original data for their own research and analysis.
