
Notes on Contributors

Luc-André Brunet is Lecturer in Twentieth-Century European History at the Open University, before which he was a Max Weber Fellow at the European University Institute and Pinto Post-Doctoral Fellow at the London School of Economics. He is the author of *Forging Europe: Industrial Organisation in France, 1940–1952* (Palgrave Macmillan, 2017) and is currently researching relations between Vichy France and the British Commonwealth during the Second World War.

Laurien Crump is Assistant Professor in the History of International Relations at Utrecht University. She specialises in multilateral diplomacy and European security during the Cold War from a Western and Eastern European perspective. She is currently working on a project on ‘The Multilateralization of European Security’ funded by the Netherlands Organisation for Scientific Research (NWO), which researches the way the Cold War was conducted through the Conference on Security and Cooperation in Europe (1972–90). Her monograph, *The Warsaw Pact Reconsidered: International Relations in Eastern Europe, 1955–1969* (Routledge, 2015), was awarded the international ‘George Blazyca Prize’ for the best book on Eastern Europe. She has conducted archival research in a wide range of European countries, and she has written numerous articles and book chapters on intra-European relations during the Cold War and beyond.

Robert Gildea is Professor of Modern History at the University of Oxford (since 2006). He is author of *Marianne in Chains. In Search of the German Occupation, 1940–1945* (Macmillan, 2002), winner of the Wolfson Prize for History; *Fighters in the Shadows. A New History of the French Resistance* (Faber & Faber, 2015); *Children of the Revolution. The French, 1799–1914* (Penguin, 2002) and *The Past in French History* (Yale, 1994). He is also co-editor of *Europe’s 1968. Voices of Revolt* (OUP, 2013).

Brian Girvin is Honorary Professor at the University of Glasgow. He is currently writing a study on the influence of Eamon de Valera on Irish politics from the 1920s to the 1980s. He is author of *From Union to Union: Nationalism, Democracy and Religion in Ireland – Act of Union to EU* (Gill and Macmillan, 2002) and *The Emergency: Neutral*

Ireland 1939–45 (Macmillan, 2006). He has co-edited *Continuity, Change and Crisis in Contemporary Ireland* (Routledge, 2010). He has published a range of articles on Irish nationalism, European integration and conservatism in Europe and the United States and has recently edited a themed journal issue, ‘The Origins of Contemporary Ireland: New Perspectives on the Recent Past’ (*Irish Historical Studies*).

Simon Godard is Assistant Professor in the History of Transnational Circulation of Knowledge at *Sciences Po* of the *Université Grenoble Alpes*. He holds a PhD from the University of Geneva and the Sorbonne on the Council for Mutual Economic Assistance (COMECON). His doctoral thesis is based on multi-archival research and analyses the COMECON as a place for the transnational socialisation of Economists in the Eastern Bloc. He worked between 2015 and 2017 on a postdoctoral research project, funded by the Swiss National Science Foundation, on the economic culture of the French and German communist parties in the interwar period. He is now working on the transnational circulation of economic concepts between Eastern and Western Europe in the Cold War period.

Simon Huxtable is a Visiting Fellow in Media and Cultural History at Loughborough University. His research focuses on the social and cultural history of late socialism, with a focus on mass media. He is the co-author, with Sabina Mihelj, of a comparative study of television during socialism, entitled *From Media Systems to Media Cultures: Understanding Socialist Television*, which will be published by Cambridge University Press. His research has been published in journals including *Cahiers du Monde russe* and the *European Journal of Cultural Studies*, as well as in a number of edited volumes. He is currently writing a monograph on the Soviet press and the public sphere after 1945, based on his doctoral research. His latest project focuses on the notion of the ‘Socialist Way of Life’ in the Soviet Union and East Germany.

Artemy M. Kalinovsky is Assistant Professor of East European Studies at the University of Amsterdam. He is the author of *A Long Goodbye: The Soviet Withdrawal from Afghanistan* (Harvard University Press, 2011) and the editor of a number of volumes on the Cold War and Soviet history. His new book, *Laboratory of Socialist Development: Cold War Politics, Decolonization, and the Struggle for Welfare and Equality in Soviet Tajikistan* (Cornell University Press, 2018), puts the Soviet development of Central Asia in international context.

Mia Lee is Assistant Professor in the Department of History at the National University of Singapore. Before coming to Singapore she worked in the History Departments of the University of Warwick, the American University in Cairo and the University of Michigan, where she completed her MA and PhD degrees. She has held fellowships from the National Endowment for the Humanities, the DAAD, the Paul & Daisy Soros Foundation and the Fulbright Program among others. She is currently finishing a book on post-war avant-garde groups in West Germany.

Iris Nachum serves as an Academic Research Coordinator (since June 2014) as well as a Research Associate (since January 2017) of the ERC project 'Judging Histories: Experience, Judgement, and Representation of World War II in an Age of Globalization' at the Hebrew University of Jerusalem. The topic of her research is 'The Impact of the Memory of World War II and the Holocaust on the West German Equalization of Burdens Law (*Lastenausgleichsgesetz*)'. Here, as well as in other research projects, she deals with the issue of ethnic co-existence in Central Europe, primarily focusing on the relations between Jews and Germans. She received her PhD from Tel Aviv University in 2017. The topic of her dissertation is: 'National Ownership and Compensation: The Career of Two Combat Concepts of the German Bohemian/Sudeten German Discourse'.

Sagi Schaefer is Assistant Professor of Modern European history at Tel Aviv University. He received his PhD from Columbia University in 2011. His book, *States of Division: Border and Boundary Formation in Cold War Rural Germany* was published in 2014 by Oxford University Press. The book analyses the process of inter-German division through the lens of border formation. He has published articles about, among other things, Iron Curtain tourism in West Germany and the connections between inter-German policies, social networks in border communities and the gradual demise of border-crossing regional identifications in Cold War Germany. His current long-term project deals with the development of transportation infrastructure and its implications for social structures in the peripheries of East and West Germany during the Cold War.

Iryna Vushko is Assistant Professor of history at Hunter College, where she specialises in the history of modern Eastern Europe. She received her PhD from Yale University in 2008 and has held several post-doctoral fellowships in Europe and at Harvard. At Hunter she teaches courses on modern Europe, Eastern Europe, imperial Russia and the Soviet Union. Her first monograph, *The Politics of Cultural Retreat: Imperial Bureaucracy in Austrian Galicia, 1772–1867*, is forthcoming with Yale University Press. She is currently working on her second book, tentatively titled *From Empire to Nation States*, which traces the lives of twenty-five individuals who started their careers in the Austrian Empire and who after 1918 parted ways into different successor states.

NOTES FOR CONTRIBUTORS

Contemporary European History covers the history of eastern and western Europe, including the United Kingdom, from 1918 to the present. By combining a wide geographical compass with a relatively short time span, the journal achieves both range and depth. It is open to all forms of historical enquiry – including cultural, economic, international, political and social approaches – and welcomes comparative and transnational analysis.

Submissions

Authors wishing to submit articles for publication should do so through the journal's online submissions system at <http://mc.manuscriptcentral.com/conteurohistory>.

Articles should normally be about 8,000 words long, the total to include footnotes. Review articles should not exceed 5,000 words.

The journal is published in English, and contributions are normally submitted in that language; however, we will also consider articles submitted in other major European languages. If accepted for publication, these will be translated. All articles, including those commissioned, will be refereed.

An abstract of each article is published in English, French and German.

Submission of a paper will be taken to imply that it is unpublished and is not being considered for publication elsewhere. On acceptance of a paper, the author will be asked to assign copyright (on certain conditions) to Cambridge University Press. An article cannot be published unless a signed copyright form is returned promptly.

Contributors are responsible for obtaining permission to reproduce any material in which they do not hold copyright and for ensuring that the appropriate acknowledgements are included in their text.

The editors would be grateful if contributors kept closely to the journal's stylistic conventions. Copy-editing is time-consuming and the editors will return any contribution which does not follow the conventions for correction and re-typing.

Contributors of accepted papers will be expected to submit a final version which should include

1. the text, which should begin with the title, the author's name and email and postal address, and the author's affiliation as he/she should wish it to appear
2. a 100-word summary of the article in English, French or German
3. a short title for use as a running page-head
4. a statement of the article's length in number of words (including both text and footnotes), and a list of tables, graphs, maps and any other illustrative material (each of which should be supplied as a separate file)
5. a short biographical note with a description of work in progress and previously published work (130 words max.)
