INTERNATIONAL CONFERENCE ON MIGRATION FEBRUARY 7-9, 1991, SINGAPORE

CALL FOR PAPERS

Rapid economic growth and changing political and social conditions in the Asia-Pacific region have fostered new migration patterns which are likely to persist into the 1990s. New patterns of migration can be discerned at the intra-regional level, e.g. within ASEAN, and at the inter-regional level, e.g. from South-East Asia and East Asia to North America and Australasia.

The Conference provides an opportunity to bring together scholars, practitioners and policy-makers from the Asia-Pacific area to analyze various dimensions of the phenomenon as manifested in the 1980s and to explore likely future trends and patterns of migration.

The themes of the Conference will be:

- 1. Overview of migration patterns in the region (ASEAN, SE Asia, East Asia).
- 2. Theories and concepts of migration in the literature.
- 3. Overview and evaluation of methodological issues in migration research.
- 4. Types and patterns of migration: voluntary migration, forced migration, internal migration, return migration and illegal migration.
- 5. Migration policy: theoretical, moral, practical and legal issues.
- 6. Country reports (ASEAN, SE Asia, East Asia).
- 7. Settlement and adaptation of immigrants.

Papers are invited on any of these themes. The Organizing Committee regrets that it is unable to provide financial assistance to paper writers. Abstracts of papers should be submitted by November 15, 1990 and completed papers by December 31, 1990 to:
