He was awarded his PhD in May 1997 from Carnegie Mellon University. He is the author of *Interrogation Nation: Refugees and Spies in Cold War Germany* (2017). His current work explores political and economic developments in eastern Germany during the 1990s.

He was awarded his PhD in December 1999 from the University of Chicago. He is the author of *Neither German nor Pole: Catholicism and National Indifference in a Central European Borderland* (2008). His current work examines the reconstruction of Roman Catholicism in Poland after 1945, with a particular focus on territories that had previously been incorporated into Germany.

JAY HOWARD GELLER is Samuel Rosenthal Professor of Judaic Studies and Professor of History at Case Western Reserve University (Department of History, Mather House, Cleveland, OH 44106; email: jay.geller@case.edu). He is the author of *The Scholems: A Story of the German-Jewish Bourgeoisie from Emancipation to Destruction* (2019) and *Jews in Post-Holocaust Germany, 1945–1953* (2005). He is the co-editor of *Rebuilding Jewish Life in Germany* (2020, with Michael Meng) and *Three-Way Street: Jews, Germans and the Transnational* (2016, with Leslie Morris).

MICHAEL GEYER is Samuel N. Harper Professor Emeritus of History at the University of Chicago (mgeyer@uchicago.edu). Among his recent publications are “Ruth Bratu (1923–2000): Hausfrau, engagierte Bürgerin. Grande Dame und Überlebenskünstlerin,” in *Juden als Darmstädter Bürger* (2019); “The Invention of World History from the Spirit of Nonviolent Resistance,” in *Islam and World History: The Ventures of Marshall Hodgson* (2018); “Verschweizerung, or: Some Brief Remarks on Sovereignty, Transnationality, and ‘Sense-Security’ in the Middle of Europe,” in *Central European History* (2018). He is currently working on a family history of the four Bratus.

SARAH MAZA is professor of history at Northwestern University (scm@northwestern.edu). A specialist in French social and cultural history ranging from the eighteenth to the twentieth

century, she has also worked extensively on questions of historical theory and methodology. Her most recent book is *Thinking About History*, published by the University of Chicago Press in 2017. Her current work compares the reception of *Uncle Tom's Cabin* in France and *Les Misérables* in the United States.

MICHAEL MENG is associate professor of history at Clemson University (Department of History, 126 Hardin Hall, Clemson, SC, 29634; email: mmeng@clemson.edu). He was awarded his PhD in May 2008 from the University of North Carolina at Chapel Hill. He is the author of *Shattered Spaces: Encountering Jewish Ruins in Postwar Germany and Poland* (2011), co-editor of *Jewish Space in Contemporary Poland* (2015), co-editor of *Modern Germany in Transatlantic Perspective* (2017), and co-editor of *Rebuilding Jewish Life in Germany* (2020), among other publications on modern European intellectual and cultural history.

AMIR MINSKY holds a PhD from the University of Pennsylvania and taught history at New York University Abu Dhabi (email: amir.minsky@nyu.edu). His work deals with the intersection of intellectual history, political theory, and the transnational history of emotions in early modern Europe, specifically focusing on the transformation of political discourse in eighteenth- and early nineteenth-century German thought.

YAIR MINTZKER is professor of history at Princeton University (History Department, 129 Dickinson Hall, Princeton, NJ 08544; email: mintzker@princeton.edu). He received his PhD in 2009 from Stanford University. He is the author of two monographs, *The Defortification of the German City, 1689–1866* (2012) and *The Many Deaths of Jew Süss: The Trial and Execution of an Eighteenth-Century Court Jew* (2017). He continues to work on European military culture in the transition to modernity and on the history of Jews in German-speaking central Europe.

STEFANIE RAUCH is research associate at University College London (Institute of Advanced Studies, Wilkins Building, Gower Street, London, WC1E 6BT; email: s.rauch@ucl.ac.uk). She was awarded her PhD in December 2014 from the University of Leicester. Her thesis was concerned with audience reception of feature films about the Holocaust. Her current work explores how changing public images affect private discourses and self-representations, by focusing on the ways in which non-persecuted Germans and Austrians negotiated shifts in moral and normative parameters after 1945.

JESSE SPOHNHOLZ is professor of history at Washington State University (Department of History, PO Box 644030, Pullman, WA 99164; email: spohnhoj@wsu.edu). He earned his PhD in 2014 from the University of Iowa. He is the author of *The Tactics of Toleration: A Refugee Community in the Age of Religious Wars* (2011), *The Convent of Wesel: The Event that Never Was and the Invention of Tradition* (2017), and *Ruptured Lives: Refugee Crises in Historical Perspective* (2020). He is current co-leading the project, *The Rhineland Refugees and the Religious Landscape of the Dutch Republic, 1550–1618*, based at the Vrije Universiteit Amsterdam, supported by the Dutch Research Council.

SIMON UNGER-ALVI is a research fellow at the German Historical Institute in Rome (email: unger-alvi@dhi-roma.it). He earned his doctorate in modern German history in 2018 at the University of Oxford, where he also taught as a college lecturer at Magdalen College. His research is concerned with patterns of accommodation and criticism in fascist dictatorships, but also with political language and religion in the twentieth century.

OLIVER ZIMMER is professor of modern European history at the University of Oxford, and Sanderson Fellow at University College Oxford (Oxford OX1 4BH, UK; email: oliver.zimmer@univ.ox.ac.uk). He is the author of *Remaking the Rhythms of Life: German Communities in the Age of the Nation-State* (2013), *A Contested Nation: History, Memory and Nationalism in Switzerland, 1761–1891* (2003), *Nationalism in Europe, 1890–1940* (2003), and a number of edited works. He is presently completing a book on time and temporality in Britain and Germany, focusing particularly on the experience of railway passengers.

Editorial Policy

Central European History publishes articles, review articles, book reviews, and other forms of scholarly writing dealing with the history of German-speaking Central Europe. The journal welcomes manuscripts using all approaches to history and dealing with all historical periods, from the medieval era to the present. The journal aims to be the primary venue for scholarly exchange and debate among scholars of the history of Central Europe. As such, all topics and approaches to history are welcome: cultural, social, political, diplomatic, intellectual, economic, and military history, as well as historiography and methodology. Because space is limited, articles that have been or soon will be published elsewhere are not accepted. Manuscripts submitted to *CEH* should not be under consideration by another journal pending decision of the editor on publication. If it is learned that an article is under submission to another journal while being considered at *CEH*, consideration will cease immediately. Unsolicited book reviews are not accepted.

All article manuscripts should be submitted via ScholarOne (<https://mc.manuscriptcentral.com/ccc>). Authors should please take care to remove any information that might identify them as author, and follow the prompts in ScholarOne to make their manuscripts anonymous. The entire text of all manuscripts, including footnotes and headings, must be prepared in double-spaced typescript with generous margins to allow for copyediting. Footnotes must be numbered consecutively.

All materials will be edited to conform with *The Chicago Manual of Style* in matters of punctuation, capitalization, and format. Final decisions on style remain with the editor.
