NOTES ON THE CONTRIBUTORS

ELIZABETH WILDER WEISMANN, one-time Assistant Keeper of the Archive of Hispanic Culture in the Library of Congress, and for forty years an independent student of the colonial art of Latin America, now lives and works in Austin, Texas.

JOHN J. TE PASKE, Professor of History at Duke University, is the author of The Governorship of Spanish Florida and editor of three works dealing with Philip II of Spain, Latin America, and comparative colonial history. He is currently engaged in a computer analysis of the cajas and cartas cuentas of Mexico and Lima, 1575-1820.

JAMES W. WILKIE, Professor of History at UCLA, won the 1967 Bolton Prize for his book The Mexican Revolution. He has published numerous works on Bolivia and Mexico and has been an innovator in the field of Oral History, in addition to Quantitative History.

KENNETH M. COLEMAN, Assistant Professor of Political Science at the University of Kentucky, is the author of a monograph entitled Public Opinion in Mexico City about the Electoral System. His current research interests include the prospects for long-term erosion of partisan identification in Mexico.

JOHN WANAT is Assistant Professor of Political Science at the University of Kentucky. His teaching and research interests are in public administration, with a focus on organization theory and budgeting, and comparative administration of developing areas. He has contributed articles to the American Political Science Review and Experimental Study of Politics.

HENRY C. KENSKI, Assistant Professor of Political Science at the University of Arizona and Research Associate in the Institute of Government Research, has written several articles on teaching in various subfields of comparative politics. He is currently collaborating on work on comparative foreign policy distance between the United States and Latin America.

WILLARD P. GINGERICH, a graduate student at the University of Pittsburgh, is completing a thesis on Nahuatl poetry, "Introduction to the Classical Nahuatl Poetry of Ancient Mexico."

RON L. SECKINGER, Assistant Professor of History at the University of North Carolina at Chapel Hill, is currently engaged in research on relations between the Brazilian monarchy and the South American republics, 1822-1831.

RAYMOND BUVE, Lecturer in Historical Sociology of Latin America, is currently on leave from Leyden State University. He has a grant from the Netherlands Institute for Advanced Studies in the Humanities and the Social Sciences to complete a study on peasant movements in Tlaxcala, Mexico during the Revolution and up to 1933.
