

H.H. Asquith: Letters to Venetia Stanley

Edited by MICHAEL and ELEANOR BROCK



Touching, surprising, always arresting, these are the letters of a British Prime Minister in his sixties to the girl he adored. H.H. Asquith fell in love with Venetia Stanley one Sunday morning in the spring of 1912. Whenever he was unable to meet her, he wrote to her—sometimes three times a day, sometimes during a debate in the House of Commons, sometimes even in a Cabinet meeting.

More than just a fascinating love story—though it certainly is that—this book also provides a rare inside look at the politics of the time. Asquith's letters reveal a statesman who faced political ruin in an Irish civil war and who escaped that fate through the war crisis of 1914. When World War I came, Asquith told Venetia every secret, discussing military plans with her before they were known to the Cabinet or to the naval and military commanders concerned! He also wrote freely of his colleagues, who included David Lloyd George and Winston Churchill.

When Venetia began to find her role as Prime Minister's friend oppressive, the suitor she had once rejected tried again. He was Edwin Montagu, a junior Cabinet Minister in his thirties, and some of the letters that passed between him and Venetia are included alongside Asquith's. Though he feared that he was losing Venetia, Asquith did not suspect that she and Montagu were planning marriage. The letter in which Venetia finally told Asquith of her engagement distressed him deeply, reaching him at a crisis in his wartime fortunes. **\$35.00, 672 pp., 30 illus.**

Prize Information

THE BRITISH COUNCIL PRIZE IN THE HUMANITIES

The North American Conference on British Studies announces the 1983 competition for the British Council Prize in the Humanities. The prize of \$750 (supported by a grant from the British Council) is awarded annually for the best book published anywhere by a North American scholar in any aspect of British studies within the following humanistic disciplines: literary history, literary criticism, history of art and architecture, history of music, history of religion and philosophy, history of ideas, intellectual history. (The competition is *not* open to works in the social sciences, including political, diplomatic, social history, etc. for which the John Ben Snow Prize has been established.) Nominations may be made by the author or by the publisher of the book to be nominated. No publisher may nominate more than one title in any one year.

The 1983 competition covers books published in 1982. Separate copies of the letter of nomination and of the book nominated should be sent by July 1, 1983 to each member of the Prize Committee (please mark packages "CBS Prize Committee"):

THE JOHN BEN SNOW FOUNDATION PRIZE IN HISTORY AND THE SOCIAL SCIENCES

The prize is awarded annually to a North American author for the best book in History and the Social Sciences in the field of British studies. The field includes most of Irish history. Studies involving the Empire-Commonwealth are eligible if they focus on relationships with Britain and British civilization. Books in the social sciences must be strongly oriented toward contributing to an understanding of the development or character of British civilization in one or more of its aspects. The book may be published anywhere in the world; nominations may be made by the author or by the publisher. The amount of the prize is \$750.

The next award of the prize will be made in Autumn 1983, to a book published in 1981 or 1982. Thereafter the prize will be awarded to a book published the preceding calendar year.
