This critique of the classic interpretations of agrarian problems represents an indispensable point of departure for understanding Mexican and Latin American rural reality. Roger Bartra shows how the Mexican peasant economy has made important steps in the accumulation of capital—an essential phase in the development toward capitalism. Yet at the same time, the peasant economy maintains its traditional systems of production.

Neither “traditional” nor “modern” (in the Marxist sense of forming a proletariat), this peasant economy nevertheless plays an important role in the overall economy of Mexico. It may also offer an alternative, Bartra suggests, to the Mexican agrarian crisis—particularly with regard to land redistribution and agricultural productivity.

Although there is already a wealth of literature that examines the causes and impacts of war on the international system, there has been little analysis of the decisions of leaders to initiate wars they are destined to lose.

The ground-breaking insight that this study introduces is that all interstate wars are not created equal. There are two fundamental types, requiring different analytical treatment — land wars and land-sea wars. Leaders from Louis XIV to Saddam Hussein have had, at best, an imperfect understanding of land-sea wars, and the author suggests that this is at the root of the defeats they eventually suffered.

Both quantitative and case study methods are applied in the testing of this "dual" theory of war. The case studies also serve to illuminate the finer points of the theory, and to illustrate Clausewitz's thesis that "war is a continuation of policy by other means," from which the work begins.

The study concludes by considering some implications of its findings for organizations, policy, and deterrence.

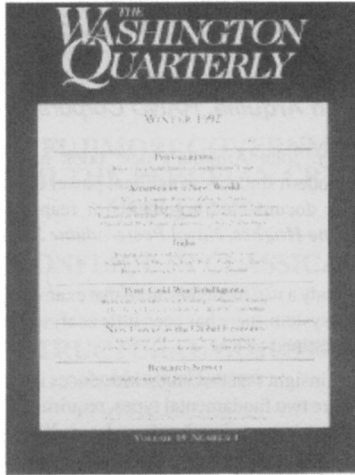

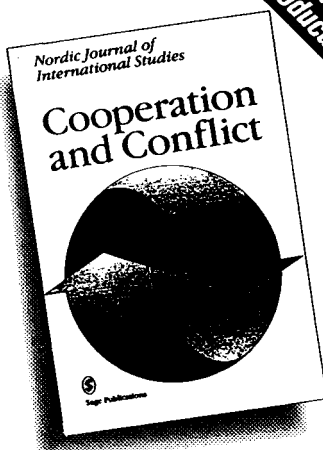

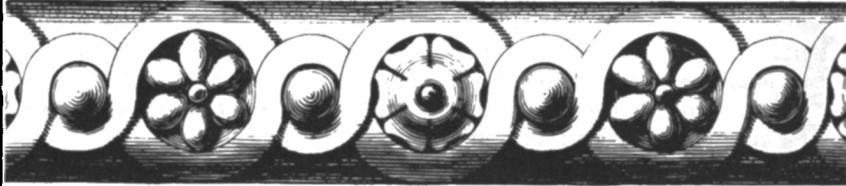
