COLLECTION OF THE AGREEMENTS CONCLUDED BY THE EUROPEAN COMMUNITIES

This major work of reference brings together the full texts of agreements made by the European Communities with non-member States or with other bodies governed by international law, particularly international organizations, and of the Community Acts concluding those agreements.

'Agreements' in this context means agreements governed by international law whether contained in a single instrument or two or more related instruments, and whatever particular titles they may have.

The scale of their economic and commercial capacity has made the European Communities an important partner on the world scene. This work bears witness also to the outward looking attitude of the Institutions, and the breadth and diversity of the external activity of the Communities in the areas covered by the treaties establishing them.

The Collection comprises five basic volumes containing the texts of all the agreements in force at 31 December 1975, amendments made to those texts before that date being referred to in the footnotes or given after the text of the agreement concerned.

The work is kept up to date by annual supplements.

REGISTER OF CURRENT COMMUNITY LEGAL INSTRUMENTS
2nd Edition

The second edition of the register of current Community legal instruments gives references for all binding Community legislation in force as at 1 January 1981:

- legislation derived from the Treaties establishing the three European Communities,
- supplementary legislation,
- agreements between the Communities and non-member countries.

References are classified by subject. For ease of research the analytical section has two indexes - one of them lists key words in alphabetical order and the other is a list of numbers. References to acts that cover several different subjects appear under each of the relevant subject headings. Wherever an act has been amended before 1 April 1981 there is a full reference to the amending act. Most of the citations are to the *Official Journal of the European Communities*.

The work is in two volumes. The first contains the analytical section, the alphabetical index and guidance for the reader. The second contains the chronological index.

A new and updated edition of the Register is published each year. This edition is published in all the Community languages with the exception of Greek. (Tome I and II).

DIGEST OF CASE-LAW TO THE EUROPEAN COMMUNITIES

D Series

The Court of Justice of the European Communities has commenced publication of the 'Digest of case-law relating to the European Communities', the purpose of which is to facilitate access to cases on Community law and thereby help towards a better understanding of that field of law.

The Digest will contain a systematic exposition of the entire case-law of the Court of Justice of the European Communities, together with selected decisions of courts of Member States. The intention is that it should eventually embrace the case-law established since 1953.

It will consist of four series, available separately, which deal with the following areas:

A Series: Cases before the Court of Justice of the European Communities, excluding matters dealt with in the C and D Series.

B Series: Cases before courts of Member States, excluding matters dealt with in the D Series.

C Series: Cases before the Court of Justice of the European Communities concerning officials of the European Communities.

D Series: Cases before the Court of Justice of the European Communities and before courts of Member States concerning the Convention of 27 September 1968 on Jurisdiction and the Enforcement of Judgments in Civil and Commercial Matters. (This series replaces the 'Synopsis of case-law' which was previously published by the Documentation Branch of the Court of Justice in several parts and which has now been terminated.)

The D Series (ca. 700 pages, folder included) is available in Danish, Dutch, English, French, German and Italian; the Greek version will appear in 1982.
