Yesenia Barragan is Assistant Professor of Latin American History at Rutgers University in New Brunswick, New Jersey. She is a historian of race, slavery, and emancipation in Colombia, Afro-Latin America, and the African Diaspora in the Americas and the author of Freedom's Captives: Slavery and Gradual Emancipation on the Colombian Black Pacific (2021) and Selling Our Death Masks: Cash-for-Gold in the Age of Austerity (2014). She is also the principal Investigator for the bilingual digital database The Free Womb Project.

Michael K. Bess is Assistant Professor of History at the Center for Research and Teaching of Economics in Mexico. He is the author of *Routes of Compromise: Building Roads and Shaping the Nation in Mexico, 1917-1952*, and co-director of mx.digital, a digital history initiative dedicated to the preservation, visualization, and teaching of Mexican historical data. He lives in Aguascalientes with his partner Dr. Mayeli Peralta Contreras, daughter Nora Xochitl, and their two cats and dog.

Robert M. Buffington is Professor of Women & Gender Studies at the University of Colorado Boulder. He has published extensively on the histories of crime/criminality and gender/sexuality in modern Mexico, Latin America, and beyond. His books include A Sentimental Education for the Working Man: The Mexico City Penny Press, 1900–1910 (2015); A Global History of Sexuality: The Modern Era, co-edited with Eithne Luibhéid and Donna Guy (2014); True Stories of Crime in Modern Mexico, co-edited with Pablo Piccato (2009); Citizen and Criminal in Modern Mexico (2000); and Reconstructing Criminality in Latin America, co-edited with Carlos Aguirre (2000).

Anderson Hagler is a PhD candidate at Duke University. His research examines conquest, religion, and sexuality in colonial Mexico. Hagler's article, "Archival Epistemology: Honor, Sodomy, and Indians in Eighteenth-Century New Mexico," which was published in *Ethnohistory* (2019), explores the ways in which Spanish colonial authorities passed judgment on the Pueblo and the landscapes that they inhabited. Hagler seeks to better understand how ethnocentrism led Spanish colonizers to interpret native peoples and their customs as inherently sinful.
