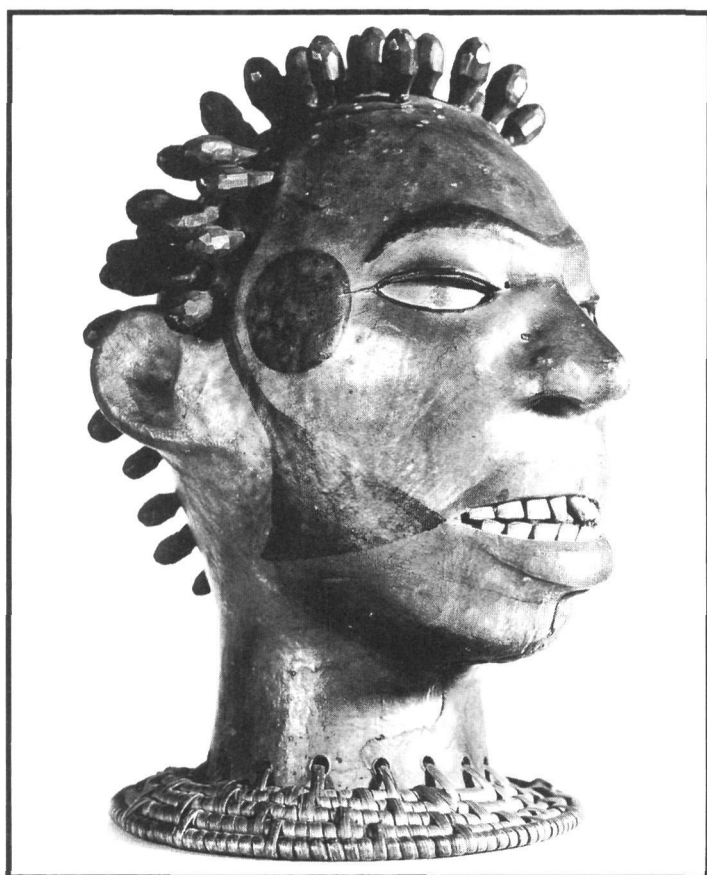

Manuscripts will be submitted anonymously to readers; please include a removable cover page giving name and mailing address, fax number and e-mail address, if available; title should be on the first page of text. Avoid self-identification as author throughout article. **Include a 250-word abstract, as well as a signed statement that the article has not been published and is not currently under consideration by other journals. ASR will only consider unpublished manuscripts.**

JANE I. GUYER is Director of the Program of African Studies and Professor of Anthropology at Northwestern University. Her most recent book publication is *Money Matters: Instability, Values and Social Payments in the Modern History of West African Communities*, an edited collection published by Heinemann in 1995. An ethnographic work, *An African Niche Economy: Farming to Feed Ibadan* will be published by Edinburgh University Press in 1997. Two further collections—*Fieldwork and Forecasting*, and *African Financial Institutions in Historical Perspective*—are in process. She is starting a new project, in collaboration with LaRay Denzer, on social and cultural responses to the decline in value of the Nigerian Naira.

FRANCIS DODOO is an Associate Professor of Sociology and Director of the African American Studies program at Vanderbilt University. His research interests lie in the areas of black migration to the USA and Europe; race and nationality stratification in America; and gender, power and reproductive decision making in Sub-Saharan Africa.

POEM VAN LANDEWIJK is a cross-cultural trainer at the Royal Tropical Institute, in Amsterdam, the Netherlands. Her research interests include cross-cultural communication; as well as resettlement, and water and sanitation issues. She is working to develop the design and production skills of small-scale artisans in Ghana.

M. ANNE PITCHER is an Associate Professor of Political Science at Colgate University, Hamilton, NY. She is the author of *Politics in the Portuguese Empire: The State, Industry, and Cotton, 1926-1974* as well as several articles on colonial and contemporary cotton production in Mozambique and Angola. She is presently analyzing the impact of privatization at the state, company and household level in Mozambique.

GAIM KIBREAB is Associate Professor at Uppsala University, Sweden. His recent publications include *People on the Edge: Displacement, Landuse and the Environment in Sudan* (London: James

Currey Publishers, 1996) and *Ready and Willing...but Still Waiting: The Dilemma of Return of Eritrean Refugees* (Uppsala: Institute of Life and Peace, 1996).

DWAYNE WOODS is Associate Professor of Political Science at Purdue University. He has published on hometown associations and the mobilization of student and teacher groups in the Côte d'Ivoire.
