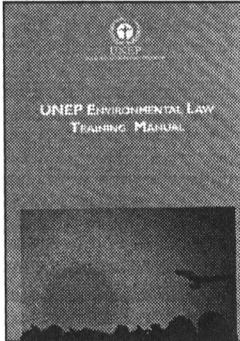

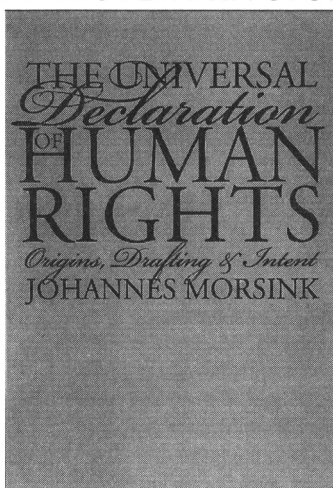

## OAK HUMAN RIGHTS FELLOWSHIP

The Oak Institute for the Study of International Human Rights at Colby College is soliciting nominations for the Oak Human Rights Fellowship.

The fellowship provides an opportunity for a human rights professional to take a sabbatical from his or her work and spend up to a semester as a scholar-in-residence at the College. While all human rights practitioners are eligible, we especially encourage applications from those who are currently, or were recently, doing "on-the-ground" work at personal risk.

The Oak Fellow's responsibilities include some collaborative teaching with members of the Colby Faculty and assistance in shaping a lecture series associated with the Fellow's area of expertise. The Fellow would also be expected to participate in the intellectual life of the campus and enable our students to work and study with a professional in the field.

The Fellow will receive a stipend and College fringe benefits plus round-trip transportation from the Fellow's home site, housing for a family, use of a car, and meals on campus. The Fellow will also receive research support, including office space, secretarial support, computer and library facilities, and a student research assistant.
