CALL FOR NOMINATIONS FOR PSO AWARDS

At the spring 1982 meeting of the Council of the Policy Studies Organization, a decision was reached to establish a PSO Awards Committee.

Those awards will cover:

- The Harold Lasswell Award. An award for outstanding scholarship in contributing to our understanding of the substances or process of public policy.
- 2. The Hubert Humphrey Award. An award for being an outstanding public policy practitioner.
- 3. The Donald Campbell Award. An award for being an outstanding methodological innovator in public policy studies.

The committee members are Aaron Wildavsky, Professor Political Science and Public Policy at UC-Berkeley (Chair); Dennis Palumbo, Director of the Center of Public Affairs at the University of Kansas; and Walter Beach of the Center for Advanced Study at the Brookings Institution.

The Committee invites nominations for any one of these three awards from people interested in policy studies. The names of nominees and descriptions of their qualifications should be sent to Aaron Wildavsky, Survey Research Center, University of California at Berkeley, Berkeley, California 94721. Nominations should be received by July 1 to be considered for 1983, although later nominations can be considered for 1984.

The winners of the awards will be announced in a brief ceremony at the annual PSO-APSA meeting on September 2 at the Palmer House in Chicago, as well as announced in the November issue of the *Policy Studies Review*.

Fiscal Stress in Cities

Conflicting pressures to increase public expenditure and restrict taxation have created fiscal stress in many major cities. In Britain the problem is heightened because central government is responsible for so large a portion of local government revenue, but not for its spending. This book attempts to identify the extent, causes and consequences of fiscal stress as it is affecting local government in the 1980s.

The author explains the political and economic forces behind Exim's creation in the 1930s, and details its activities to 1980. He analyses the Bank's major credit and guarantee programmes, showing how they fulfil important needs in banking and industry, and demonstrates the role of Exim as an instrument of financial leverage in American diplomacy.

Social Experimentation and Economic Policy

ROBERT FERBER and WERNER Z. HIRSCH

This volume considers the advantages and disadvantages of social experimentation relative to other means of evaluating economic and social policies. The main part of the book provides a review and critical evaluation of the principal social experiments in economics carried out so far in the USA, where this method has been used very extensively.

GENERAL APPROACH

Authors are asked to bear in mind the nature of the readership when writing their contribution. In particular, care should be taken to draw out the implications of the analysis for readers interested in other policy fields, other countries and other disciplines. Jargon specific to a particular discipline should be avoided, and definitions should be provided for words which might be unfamiliar to many readers.

It should be borne in mind that some readers may not be familiar with complex statistical methodology. Accordingly, verbal statements of major findings should always be included. Statistical points can be discussed in notes. Complex statistical or methodological points might merit an appendix. Where you feel that an understanding of the approach used is important in interpreting the substantive findings it might be advisable to explain this in terms comprehensible to the non-specialist in a 'box' which can be placed at the appropriate point in the text. Similarly, while the editor recognizes the

importance of work that proceeds deductively from high-level theoretical abstractions, articles for this Journal will be expected to show clearly what their substantive significance is in terms of issues arising in a governmental

context.

PREPARATION OF MANUSCRIPT The entire manuscript, including footnotes and references should be typed double-spaced on one side only of A4 sized paper, with a left-hand margin of at least 13 inches (42 cm). Manuscript pages should be numbered consecutively.

The title of the article and the author's name and affiliation should be typed on a separate

page at the beginning of the article.

The title only should appear on the next page, which should contain an abstract of the article of not more than 150 words.

STYLE

Spelling, capitalization and punctuation should be consistent within each article. Detailed advice on all matters of style is contained in Judith Butcher's book, Copyediting, Cambridge University Press (1975).

Headings of not more than two grades should be used and they should be typed on separate lines.

Tables and Figures should be numbered consecutively in separate series. Each table or figure should be typed or drawn on a separate sheet. Every table or figure should have a title or caption and at least one reference in

the text to indicate its approximate location.

Notes should be avoided wherever possible. Notes should not be used for bibliographic references (see below). When they must occur, notes should be numbered consecutively throughout the article. They will be printed grouped together at the end of the article as endnotes. Notes should be typed in a single list at the end of the paper, starting on a

new page.

Bibliographic citations in the text must include the author's surname and year of publication and may include page references. Complete bibliographic information for each citation should be included in the list of references at the end of the paper. Examples of correct styling for bibliographic citation where the author's name is mentioned in the text are Alford (1975), Biller (1976, 136-7), May and Wildavsky (1978), Ostrom, Parks and Whitaker (1978) and subsequently Ostrom et al. (1978). Otherwise, use, e.g. (Biller, 1976,

References should be typed in alphabetical order in a single list at the end of the paper, starting on a new page, using the style of the

following examples:
