
HISTORY WORKSHOP



Solidarity and Fragmentation

Working People and Class Consciousness in Detroit, 1875-1900

RICHARD OESTREICHER



Oestreicher argues that social change in Detroit can be understood neither in terms of the proletarianization and polarization predicted by classical Marxism nor as the struggle between tradition and modernity hypothesized by modernization theorists. Solidarity and fragmentation, he suggests, were intertwined parts of the same whole, both fundamental aspects of workingclass experience.

"Solidarity and Fragmentation combines the virtues of a detailed local study with general insights into both the character of working-class consciousness in the 1880s and the nature of the controversies within the Knights of Labor. Among all the fine recent studies of the Knights, this is the one that most effectively links the questions emphasized by the more recent trends in social history to the issues of the older historiography. It is enormously helpful to those of us who have for so long been trying to sort out the complex evolution of the labor movement in the last two decades of the nineteenth century." — David Montgomery.

All manuscripts must be typed on one side of the sheet only, on 8½ " x 11" nonerasable bond paper, with ample margins. *All* material—including notes, quotations, bibliographies, tables, and appendixes—must be double-spaced. Notes should be grouped together at end of manuscript and should conform to models in the *Chicago Manual of Style*, 13th ed. Maximum length of manuscripts: scholarly controversies, 35 pages including notes; substantive articles, 35 pages including notes; controversy critiques, 8 pages; review essays, 25 pages including notes; book reviews, 8 pages; reports, 8 pages; letters to the Editor, 3 pages. Address manuscripts, correspondence, and books for review to Editor, *ILWCH*, Department of History, Hall of Graduate Studies, Yale University, New Haven, CT 06520.
