MAKING FRIENDS

Often when an Inspector of the N.S.P.C.C. first calls at a home his visit is resented, but usually he eventually comes to be regarded as a friend.

Some months ago one of the Inspectors was told that a three years old boy was kept in his room all day long and was not allowed to play with his sisters. The boy's mother—who was of low intelligence—said that she did not like boys, and that she was upset because her son was a bed wetter. The father could only suggest the boy should be sent to his grandmother, to which the mother would not agree. The Inspector had a talk with her and later consulted a Health Visitor and a doctor who were interested in the boy and who gave the mother some sound advice about the bed wetting.

As a consequence, the boy is now having a much better time. The mother had at first resented the Inspector's intervention but she now looks upon him as a friend.

Cases like this—an actual case on the N.S.P.C.C. files—are dealt with frequently by the Society: for the scope of the Society's work is very much wider than cases of cruelty or gross neglect. If the Society can do anything at any time to help children whose welfare, happiness or future is in jeopardy, it will do so. This humanitarian work depends on your subscription and support. 
