A Century of Debt Crises in Latin America

Carlos Marichal contends that the boom-and-bust cycles of Latin American foreign loans result mainly from the fluctuations of the world economy, rather than from errors made in Latin America itself. Marichal shows that the present debt crisis is only a part of an overall pattern in Latin American history—cycles of loan boom and subsequent debt crisis that are heavily influenced by fluctuations of international trade and capital flows. Examining the strategies of both lenders and borrowers, he also makes it clear that foreign loan negotiations are not only financial tools but also political instruments with broad economic and social consequences.
