These have never before been published. Also included in the historically significant material in this book are numerous verbatim accounts of conferences in the Kremlin, at 10 Downing Street, the British Foreign Office, the White House, and the State Department. This study is *must* reading for anyone seriously interested in the Eastern European situation.

All copies that could be found were collected and burned, but the few that remained in circulation had profound effects on the thinking of the young intelligentsia. ## ***The Agrarian Foes of Bolshevism***

**OLIVER H. RADKEY, Jr.**

A study of the Socialist Revolutionary Party, the political expression of the peasant movement in Russia. Dr. Radkey describes its role during the critical period of February to October, 1917, discussing the errors and deficiencies of leadership by which the party lost its power, and points up the contributions to socialist theory, particularly by Victor Chernov, that influenced the Bolshevik wing of the Social Democrats. This account of Russia in 1917 is not only a vivid picture of how a revolution actually happened; the book also goes far to explain the paradox of the seizure of control in a peasant land by a proletarian party—the Bolsheviks. Dr. Radkey has done exhaustive research in a wide range of sources in both printed and manuscript form, many of them rare and used here for the first time, and he has talked with key men in the movement. In the author's view, the Russian peasantry was a revolutionary force in its own right, but its inherent weaknesses, together with the difficulties of the hour, the shortcomings of its intellectual leadership, and the purposeful distortion by the Communists have denied this force its rightful position in the literature of the revolution. *Studies of the Russian Institute, Columbia University.* \$8.50

## ***Soviet Marxism* A CRITICAL ANALYSIS**

**HERBERT MARCUSE**

To explain the general direction and some of the major changes in Soviet Marxism, Dr. Marcuse considers the historical reality behind Soviet doctrine from the point of view of its basic Marxian concepts. He reexamines these concepts in the light of the historical development that has made them determining factors in the Soviet system. This "immanent critique," as he calls it, gives meaning to much that is commonly written off as "Kremlin propaganda." The author explains: "The extreme poverty and even dishonesty of Soviet theory would not vitiate the basic relation between theory and reality but would itself provide a clue for the factors which engendered the obvious theoretical deficiencies." Dr. Marcuse then analyzes Soviet doctrine through Leninism, Stalinism, and post-Stalinism, defining its apparently shifting aspects in terms of stages of development which are logical within the system. He also shows how the Soviet pragmatic ethical code is an integral part of the social dynamic of the Soviet state.
