Resolutions

If proposers of resolutions file them with the Executive Director by Monday, June 4, they will be published in the summer *PS*.

Wednesday, August 1, 5:00 p.m.

All proposed resolutions must be filed with the Executive Director.

Membership Notice

By August 30, an official notice will be sent by the Elections Committee to all individuals whose membership will expire in the quarter prior to the election.

Nominations

If nominations are submitted prior to the Annual Meeting, they should be filed together with the required ten signatures with the Chairperson of the Elections Committee in care of the Association no less than four days prior to the Annual Meeting. If nominations are filed at the Annual Meeting, they must be filed with the Chairperson of the Elections Committee, at the APSA Office at the convention hotel, according to the Constitution, by at least twenty-four hours prior to the Annual Business Meeting.

1979-80 APSA Black Graduate Fellowships

Congressional Fellowship Program

The Association has announced five winners in the national competition for the 1979-80 Congressional Fellowship Program.

*If necessary, a second Business Meeting will be held at 11:45 a.m. on Monday, September 3.

An open forum with candidates for APSA offices will be held at 11:45 a.m. on Friday, August 31.

The winners—three political scientists and two journalists—will come to the Nation's Capital for a year of full-time work in the offices of Senators and members of the House of Representatives.

Sponsored by the Association since 1953, the purpose of the Congressional Fellowship Program is to give outstanding young academicians and political journalists an opportunity to further their knowledge of the national legislative process. Other participants in the 1979-80 Congressional Fellowship Program, Asian Fellows, Harkness Fellows, Johnson Health Policy Fellows, and Federal Service Fellows, will be named later in the year.

The Congressional Fellows are scheduled to arrive here in mid-November for a three-week orientation period. They will begin working in Congressional offices of their choice about December 1, 1979. The Program ends August 15, 1980.

The five winners were selected on the basis of superior academic training and experience. Final selections were made by an Advisory Committee made up of top government officials, Washington newsmen, and political scientists.
