The American Institute for Contemporary German Studies, an affiliate of The Johns Hopkins University, invites applications for a research fellowship in the social sciences for the academic year 1988–89. The Fellowship will be supported by the Hoechst Celanese and Siemens Capital Corporations.

Applicants must hold a doctoral degree, be U.S. citizens or permanent residents, and demonstrate German language competency. Preference will be given to applicants specializing in the disciplines of political science (including international relations and comparative politics), economics (including international economics and trade), or post-World War II history. Experience in conducting symposia and workshops is also desirable.

A successful applicant will be expected to conduct a research project in residence, organize a series of three or four seminars, prepare a monograph-length paper, and deliver at least one public lecture under the Institute's auspices.

The fellowship includes a monthly stipend appropriate to experience and/or faculty rank, housing and insurance allowances, and at least one overseas travel allowance.

Applicants should submit a three-page outline of the research project to be pursued, stressing the uniqueness of the project, the methodology, timetable, and the applicant's qualifications, a c.v., and three letters of recommendation. Selection will be made by a panel of five qualified experts, and candidates will be notified by May 15, 1988.
