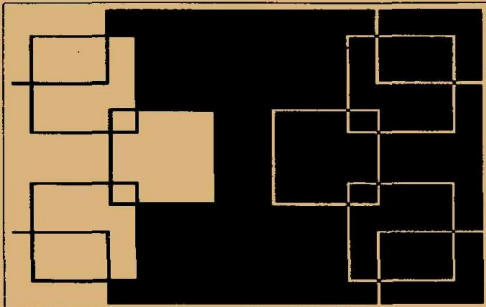

Club, Flanigan, and Zingale discuss the interrelationships between voting behavior in the mass electorate and patterns of party control of government policy-making institutions. Their investigation focuses on the realignment perspective—the theory that the political history of the United States is marked by repetitive sequences, or party systems, each beginning with a partisan realignment that involved the appearance of a new electoral alignment, which endured for a significant time and then deteriorated. Through the use of both historical data and quantitative techniques, the authors expand upon traditional discussion of the realignment perspective, explicitly linking mass voting behavior with political leadership, and revealing that historical realignment sequences are marked by similar stages of control of government, elite behavior, and policy formation.
