




Cover Art: Recently installed wind turbines erected next to Drax, Europe's biggest coal fired power power station in Selby, England (August 24, 2010). The Rusholme wind farm creates 24 Mega Watts—enough to supply power for an estimated 14,000 households. By comparison, Drax creates 3,960 Mega Watts and supplies 7% of Britain's electricity. According to a recent article in the Guardian, Drax is Britain's biggest emitter of carbon dioxide—about 22m tons in a typical year. (http://www.guardian.co.uk/environment/2010/feb/25/greenwash-drax-power-plant, accessed 02/04/2011) "It emits as much CO2 as one-quarter of all Britain's cars, and more than all the planes taking off from Heathrow in a year. It emits more than the whole of Sweden... Under the EU emissions trading scheme, Drax only has permission to emit 9.6m tons of CO2, less than half its actual emissions. It has to buy permits to make up the difference." The article explains the position of Drax chief executive officer as follows: "Thompson says that if it is cheaper to burn coal and buy the permits, that is what she will do." 
