The authors, who are experts in this special field, distinguish three periods.

In the first three Parts they deal with conventional belligerent occupation, Military Government and Allied High Commission. Part Four deals with the position of the Federal Republic in the North Atlantic Community with particular reference to her relations with 'the Big Four.'

The main legal issues are broadly surveyed, and described only so far as they appear material to the legal issues.

This contemporary survey conveys a better understanding of the principles and rules of international law than is possible through any textbook exposition.

# The Rule Against Perpetuities

*“One of the delights of the perpetuity rule is the scope it offers for debate within a logical and coherent framework.”*

The Authors have taken up this challenge on both counts. First, they have restated this complicated body of law within a logical and coherent framework and as shortly and as simply as the subject permits. Secondly, within this framework, they have offered considerable critical comment of existing doctrine. This criticism, segregated and designated as such, examines the anomalies which have crept in over three centuries and points the way to a more workable body of rules.

The book abounds in illustrations; these illustrations, each stated in simple language, bring out the essential point more clearly than could pages of description. All the relevant decisions from England, Ireland and the British Commonwealth have been cited; in addition, American experience has been drawn on wherever it appeared to have something useful and constructive to offer for possible emulation.

Throughout the work the main emphasis is placed on the way the Rule functions in its modern environment and how it fulfils the needs of modern society. Not content with stating the present position, the Authors have set out to show how the law of perpetuities can be adapted to present-day requirements and be freed from the defects of existing doctrine.

While the book was in the press, it was announced that the Lord Chancellor had referred the topic of perpetuities to the Law Reform Committee. When the Committee's Report is translated into an amending statute, a Supplement will be issued in which the Authors will explain and comment on the statutory provisions.
