The MBA is also a registered charity with its key aims being to promote scientific research into all aspects of life in the sea, including the environment on which it depends, and to disseminate to the public the knowledge gained. The Patron of the Association is His Royal Highness the Duke of Edinburgh, who is also an Honorary Fellow. The other Honorary Fellows are His Serene Highness Prince Albert of Monaco, Dr Sylvia Earle, Sir Tim Hunt and Professor James Lovelock.

The work of the Association is controlled by the Council elected annually by its subscribing members.

The Marine Biological Association, under the direction of its Council, has undertaken research in all branches of marine science and many of the results have been published in this Journal.
