Parliament, Party, and the Art of Politics in Britain 1855-1859

Angus Hawkins. This study examines a complicated, critical, and neglected period in British politics, a period that led to the formation of the Liberal party and the reestablishment of a distinct two-party system. The author analyzes the policies, motives, and strategies of British politicians in Parliament, with emphasis on the interplay between three men—Lord Palmerston, Lord Derby, and Lord John Russell—and their followers. His reappraisals of such events as Palmerston's ascendancy following the Crimean War, reaction to the Indian mutiny, and the Orsini crisis alter previous perceptions of party activity during the 1850's. \$38.50

The Governance of Norman and Angevin England 1050-1272

W. L. Warren. More than simply a history of administration, this book is an investigation of how England was controlled and managed in the two centuries after the Norman Conquest. Although these years saw the crucial development of a centralized administration under the crown, Professor Warren also describes other aspects of government that are no less important. For example, he challenges the accepted view that the Normans took over and improved on Anglo-Saxon government, asserting instead that there was a break with tradition and that Norman innovations averted a crisis in government.
