

The Division of Infectious Diseases in the Department of Medicine at the University of Pennsylvania School of Medicine seeks candidates for an Assistant Professor position in either the nontenure academic-clinician track or the non-tenure clinician-educator track. Track will be commensurate with experience. Applicants must have an M.D. degree. While evidence of scholarship is required in the clinician-educator track, research is not required in the academic clinician track. Board Certified and Board Eligible in Infectious Diseases.

The candidate will participate Healthcare Epidemiology programs including efforts to prevent blood stream infection and MRSA in hospital, and preparedness programs for pandemic and bio-terrorism attacks. anticipate that 80% time will be spent doing hospital infection control and 20% clinical care and teaching. Scholarship in the form of publications focused on healthcare epidemiology is expected for reappointment and promotion in the clinician-educator track.

The candidate will be a member of the Hospital of the University Healthcare Epidemiology program under the direction of Dr. Neil Fishman. Healthcare Epidemiology is noted for its leadership in the areas of microbial and antibiotic stewardship.
