Martha Ackelsberg is William R. Kenan, Jr. Professor of Government and of the Study of Women and Gender at Smith College. She is the author of *Free Women of Spain: Anarchism and the Struggle for the Emancipation of Women* (1991, 2005) and of *Resisting Citizenship: Feminist Essays on Politics, Community, and Democracy* (Routledge 2010). Her response to Martha Nussbaum's "A Right to Marry" was posted to *Dissent* on-line in June 2009.

Debra L. DeLaet is Professor of Politics and International Relations at Drake University in Des Moines, Iowa. She has published two books: *U.S. Immigration Policy in an Age of Rights* (Praeger 2000) and *The Global Struggle for Human Rights* (Wadsworth 2006). Her work on human rights and gender issues has also been published in *Polity* and *Global Change, Peace & Security*, and she has a forthcoming article in the *Journal of Human Rights*.

Alesha E. Doan is Assistant Professor of Political Science at the University of Kansas. Her research combines a range of theoretical perspectives and methodological techniques to examine social policies, with a specialized focus on reproductive policy. She has published two books, *Opposition and Intimidation* (University of Michigan Press 2007) and *The Politics of Virginity: Abstinence in Sex Education* with Jean C. Williams (Praeger Publishers 2008).

Debra L. Dodson is Director of Program Evaluation and Outcomes Measurement within the Girl Scout Research Institute, at Girl Scouts of the USA. She has authored numerous works exploring gender difference and political impact, including *The Impact of Women in Congress* (Oxford University Press 2006). Dodson is currently focusing on gender, leadership, girls, mentorship, and generational change as she works within the Girl Scout Movement to implement and evaluate the New Girl Scout Leadership Experience.

Marianne Githens is Distinguished Professor of Political Science and Chair of Women's Studies at Goucher College. Her publications include *A Portrait of Marginality*, co-edited with Jewel Prestage; *Abortion: Public Policy in Cross Cultural Perspective*, co-edited with Dorothy Stetson; *Different Roles, Different Voices*, co-edited with Joni Lovenduski and Pippa Norris, and numerous articles on women and politics. She is currently finishing a book manuscript on the impact of immigration on the social construction of women's identity.

Donald P. Haider-Markel is Professor of Political Science at the University of Kansas. He has authored and co-authored over 40 refereed articles, multiple book chapters, and a book in a range of issue areas, including the civil rights, environment, religion and the culture wars, and criminal justice. He has been recipient or co-recipient of grants from the EPA STAR program, the National Science Foundation, and the American Psychological Foundation.

Jyl Josephson is Associate Professor of Political Science and Women's and Gender Studies at Rutgers University-Newark. She is the author of numerous articles on gender, sexuality, and public policy in journals such as *Perspectives on Politics*, *Journal of Poverty*, *New Political Science*, *Journal of Political Ideologies*, and *Women & Politics*. With Cynthia Burack, she is editing a series for SUNY Press called "Queer Politics and Cultures." She is currently completing a manuscript on sexual citizenship.

Erin Kaheny is Assistant Professor of Political Science at the University of Wisconsin – Milwaukee. Her research interests involve federal appellate court decision making, judicial careers and acclimation effects, attorneys and the judicial process, and comparative judicial studies.

Priscilla A. Lambert is Assistant Professor at Western Michigan University. Her research focuses on comparative social policy, Japanese politics, and women and politics. Her recent work has appeared in *Comparative Politics* and *Social Politics*.

Lori Marso is Professor of Political Science and Director of Women's and Gender Studies at Union College in Schenectady, New York. She is the author of *Feminist Thinkers and the Demands of Femininity: The Lives and Work of Intellectual Women* (2006) and *(Un)Manly Citizens: Jean Jacques Rousseau's and Germaine de Staël's Subversive Women* (1999)

and co-editor of *Simone de Beauvoir's Political Thinking* (2006) and *W Stands for Women: How the George W. Bush Presidency Shaped a New Politics of Gender* (2007).

Tamara Metz is Assistant Professor of Political Science and Humanities at Reed College. She is the author of *Untying the Knot: Marriage, the State and the Case for their Divorce* (forthcoming, Princeton University Press), "The Liberal Case for Disestablishing Marriage," *Contemporary Political Theory* (2007), and "The Future of Marriage," in *Marriage and Family* (Columbia 2009). Her next project, *Care in a Free Society*, engages the challenges of meeting the demands of care in diverse, liberal democratic polities of a globalized world.

Rainbow Murray is Assistant Professor of politics at Queen Mary, University of London. Her forthcoming monograph is entitled *Parties, Gender Quotas and Candidate Selection in France* (Palgrave). She is editing a forthcoming book with Praeger on women candidates for executive office worldwide. She has published in numerous journals including *Party Politics*, *French Politics* and *Parliamentary Affairs*. Tammy Sarver is Associate Professor of Political Science and Pre-law advisor at Benedictine University in Lisle, Illinois. Her areas of research interest include the role of attorney gender in appellate court outcomes, interest group activity in the U.S Courts of Appeals, and judicial decision making across the American and Canadian federal courts.

Druscilla L. Scribner is Assistant Professor at the University of Wisconsin, Oshkosh. Her research is focused on comparative judicial politics in Chile and Argentina and on gender and constitutional law cross-nationally. She is the author of articles in *Comparative Politics* and the *Journal of Latin American Urban Studies*.

Mangala Subramaniam is Associate Professor of Sociology at Purdue University. Her work in the areas of gender and social movements, including transnational movements, has been published in *Critical Sociology*, *Mobilization*, and *Gender & Society*. Her latest book, *The Power of Women's Organizing: Gender, Caste, and Class in India*

(Lexington 2006), focuses on the women's movement in India with specific attention to *dalit* women's organizing. The gendered dimension of dowry and marriage among South Asians is the theme of her forthcoming co-edited volume. Her current work focuses on the ways in which NGOs, in a trans-local environment, deploy gendered scripts to disseminate information about HIV/AIDS in Southern India, and the collective responses of community based groups to using and saving water in the wake of increasing privatization, which is a major tenet within the neo-liberal agenda being pursued by the Indian state.

John Szmer is Assistant Professor of Political Science at the University of North Carolina at Charlotte. His research focuses on various aspects of appellate judicial behavior, including judicial efficiency, as well as the impact of information, gender, party capability, and attorney characteristics.

Angelia Wilson is Senior Lecturer in Politics at the University of Manchester, UK. Her research explores the intersection between feminist political theory, queer theory and policies regulating sexuality. Her publications include *Below the Belt: Sexuality, Religion & the American South*, *Activating Theory, A Simple Matter of Justice?* and *Why Europe is "Gay Friendly" (And Why America Never Will Be)* (forthcoming) as well as articles in *Contemporary Politics, Sexualities, Critical Social Policy and Culture, Health and Sexuality*.

MANUSCRIPT PREPARATION

- Manuscripts must be no longer than 30 pages including text, tables and figures, references and appendices. The entire manuscript (including notes and references) must be double-spaced, with one-inch margins and 12-point font, and printed on one side of the page only.
- The author must include a separate title page, with his or her full contact information (including email address, telephone number and institutional affiliation), and a brief biographical statement. All identifying information must be removed from the manuscript.
- A second page must include an abstract of no more than 200 words.
- Placement of tables or figures should be cited in the text. The publisher will be responsible for placing artwork, tables or figures, as well as converting endnotes to footnotes.
- Appendices, tables, and figures should be numbered consecutively throughout the article and be included on separate pages

appearing after the reference section. Figures should be ready for photographic reproduction; they cannot be redrawn by the publisher. Charts, graphs, or other artwork should be professional rendered or computer generated. Photographs should be clearly printed and should remain legible after a 50% reduction.

- References and notes should conform to the APSA Style Manual. Authors should include full volume, issue, and page numbers for references. Author's acknowledgments or other personal notes will appear as an unnumbered note at the foot of the page. Notes should be numbered consecutively throughout the article. Numbered notes should appear at the end of the sentence. If multiple texts are cited in a sentence they should appear as one consolidated note at the end of the sentence.
- Endnotes should be employed (rather than footnotes).
- All figure captions should be typed on a separate page (or pages), rather than on the figures themselves (which are camera-ready art) so that they can be copyedited.

Originality and copyright: Papers with multiple authors are reviewed with the assumption that all authors concur with its submission. A Copyright Transfer Agreement, with certain specified rights reserved by the author, must be signed and returned to the Editor by senior authors of accepted manuscripts, prior to publication. *Politics & Gender* does not accept manuscripts for review that are under review elsewhere, previously published or already committed for publication.

For general guidelines for preparing a manuscript for submission, please refer to the *APSA Style Manual for Political Science* (rev. ed. 2001) for citation, footnotes, references, and other style issues. Please note, in particular, the statement on gender-specific language (15).
