Ebsworth, who had most kindly promised to draw and engrave on wood four interesting illustrations from the original black letter edition of the "Spousells" of the Princess Mary, daughter of Henry VII. His state of health, unfortunately, has only enabled him to execute one of them, notwithstanding that he had made drawings of the other three, and when he was obliged reluctantly to abandon the task the Council did not think fit to delay publication further. On the other hand, the delay has enabled the Council to include in the Volume a most acceptable contribution from Dr. Sparrow Simpson, which he has been kind enough to present to the Society at his own expense.
