The Christology of the New Testament

Dr Cullmann takes each of the New Testament titles of Christ, and examines what they meant to the world to which Jesus came, whether in orthodox Judaism, in circles like those of Qumran, or in the Hellenistic world. He goes on to investigate how much we can know of Jesus' own attitude to, and use of, each title. Finally, he discusses the way each of these concepts shaped, and was shaped by, the thinking of the early Church. His conclusion is that New Testament Christology does not date from the experience of the early Church, but goes back to the life and 'self-consciousness' of Jesus himself.

Paul and the Salvation of Mankind

In this book a distinguished Danish scholar, Professor at Aarhus University, subjects to a radical re-examination the assumptions on which Pauline studies have largely been built for over a century—assumptions that go back to F. C. Baur and the Tübingen School. He seeks to show that Paul was not the universalist standing over against Jerusalem's particularism. He does not believe that there was any Judaizing party in Jerusalem. Looking at Paul's missionary strategy Professor Munck believes that he sought, by winning the first-fruits of every nation for Christ, to achieve the fullness of the Gentiles in this representative sense.
