# The Contributors

STEPHEN AMICO is an Assistant Professor in the departments of Music and Media Studies at the University of Amsterdam. His book *Roll Over Tchaikovsky! Russian Popular Music and Post-Soviet Homosexuality* is due out from University of Illinois Press in 2014, and he has begun work on a project devoted to the female/feminine voice and body in Soviet and post-Soviet popular music.

SAM DE BOISE is a teaching fellow in the Department of Sociology at the University of York. His research looks at the intersections between emotions, men and masculinities from a critical, feminist perspective and he is currently writing a book on emotions, affect, masculinities and music. Other research interests include music's role in capitalist reproduction and gender and neoliberalism.

MARITA BUANES DJUPVIK BA (2003), MA (2005), in musicology from the University of Oslo, is currently completing a PhD in musicology at the University of Agder, Norway, under the supervision of Professor Stan Hawkins. Her research focuses on audio-visual analysis and questions of gender and ethnicity.

PAUL FLEET is Lecturer in Music and Degree Programme Director for the BA in Contemporary and Popular Music at Newcastle University, where he is also the Head of music skills provision across the department's four degree programmes and is Chair of the Undergraduate Board of Studies. He has previously published a monograph on Ferruccio Busoni, and has research interests in analysis, philosophy, time-consciousness, metatonal music, fusion musics and progressive rock guitar techniques.

MATTIAS LUNDBERG (b. 1976) is an Associate Professor at the University of Uppsala. He has published books, articles and editions concerning music theory and analysis, music and scholarly erudition in early-modern Europe, compositional processes in counterpoint, Lutheran liturgical music and progressive rock of the 1970s.

VICTORIA MALAWEY is Assistant Professor of Music at Macalester College where she teaches courses in music theory, popular music studies, and gender and music. She completed her PhD in music theory at Indiana University with a dissertation on Björk's *Medúlla*, which won the Dean's Dissertation Prize in 2009. Her articles on popular music have appeared in *The Journal of the Royal Musical Association*, *Music Theory Online*, *Indiana Theory Review* (forthcoming), and she is a contributor to *Pop-Culture Pedagogy in the Music Classroom*.

THOMAS ROBINSON is Assistant Professor of Music Theory at the University of Alabama School of Music. His research focuses on 20th-century music and popular music, and he recently contributed 'Analyzing Pärt' to *The Cambridge Companion to Arvo Pärt* (Cambridge University Press).

JONATHON WINTER is a postgraduate at Newcastle University. His research interest centres on rhythmic and structure analysis of drum grooves in relation to genre innovation. He is currently researching the transition of swing rhythms to straight rhythms within the rise of rock and roll.
