THE CONTRIBUTORS

ROBERT A. LEVINE, Research Associate of the Center for International Affairs at Harvard University, is working on a study of the limits of ideology and analysis in determining armament and military policy. He is on leave during the current academic year from The RAND Corporation, where he is an economist in the Logistics Department.

Myron Rush, a staff member of The RAND Corporation, is the author of *The Rise of Khrushchev* (1958). He recently completed a study of the political use of Soviet strategic power (with Arnold Horelick as co-author) and is now engaged in a booklength treatment of Khrushchev as a political leader.

JOHN McVickar Haight, Jr., Assistant Professor of History at Lehigh University, is investigating Franco-American relations in the period from 1935 to 1940. His article, "France, the United States, and the Munich Crisis," which appeared in the Journal of Modern History in December 1960, received honorable mention for the William Koren, Jr., Prize awarded by the Society for French Historical Studies.

CALVIN A. WOODWARD, a Ph.D. candidate in the Political Science Department of Brown University, holds a University Fellowship for graduate study. He is working on his dissertation, tentatively entitled "The Parties and Party System of Ceylon."

ERNST B. HAAS, Associate Professor of Political Science at the University of California, Berkeley, is engaged in studies on the integrative impact of international organizations. His recent publications include *The Uniting of Europe* (1958) and *Consensus Formation in the Council of Europe* (1960).

RICHARD A. FALK, Associate Professor in the College of Law at Ohio State University, is spending 1961-1962 as Research Associate of the Center of International Studies and Visiting Lecturer in the Department of Politics at Princeton. He edited *International Jurisdiction* (1961) and a volume on international law and espionage scheduled to appear later this year.

Douglas E. Ashford, Assistant Professor of Government at Indiana University, is conducting a comparative study of local political participation in Morocco, Tunisia, and Pakistan with a grant from the SSRC-ACLS Joint Committee on the Near East. His book *Political Change in Morocco* appeared in 1961.

ROBERT WAELDER, a psychoanalyst in Philadelphia, has a long-standing interest in political and historical problems and has published a number of articles dealing with them in psychological terms. The author of Basic Theory of Psychoanalysis (1960), he is now preparing a book on theories of history.

LOUIS MORTON, Professor of History at Dartmouth College, is the author of Fall of the Philippines (1953) and The Pacific War: Strategy and Command (in press). He and Gene M. Lyons are completing a study entitled "The Intellectual Response to the Cold War."

GLENN H. SNYDER is Associate Professor of International Relations and a staff member of the Social Science Foundation at the University of Denver. He is the author of Deterrence and Defense (1961) and co-author of a forthcoming volume, Strategy, Politics, and Defense Budgets.
