Details the crucial economic impact on host countries of U.S. direct investment in two high-technology industries. Analyzes the policy implications and proposes guidelines for an overall European policy on U.S. direct investment. Aug., 1973, 316 pp., tables, \$17.50.

THE CHINA TRADE AND U.S. TARIFFS. *Harry A. Cahill*. Discusses the experience of American buyers since the lifting in July 1971 of the 21-year U.S. embargo on trade with China; Chinese trade with the rest of the world is compared with the potential for trade with the U.S. on a product-by-product basis. Focuses on the impediment to bilateral trade created by the denial of the most-favored-nation (MFN) tariff status. June, 1973, 170 pp., tables, figures, appendix, bibliog., \$15.00.

DOING BUSINESS WITH THE PEOPLE'S REPUBLIC OF CHINA: American Trade Opportunities in the 1970's. Edited by *William W. Whitson*. A market survey of prospects for the sale of American products in over 25 industry and trade categories to the People's Republic of China. Outlines practical steps whereby management can approach trading with China at the least cost in money and executive time. Sept., 1973, ca. 400 pp., appendix, tables, ca. \$21.50.

THE ROLE OF COMMUNICATIONS IN THE MIDDLE EAST CONFLICT: Ideological and Religious Aspects. *Yonah Alexander*. Analyzes the ideological conflict between Arab nationalism and Zionism which lies at the core of the Middle East conflict. Sees the antagonists using religion as an instrument of nationalism, thereby contributing to the emotional and intellectual chasm which has led to belligerence for 25 years. Sept., 1973, ca. 200 pp., tables, bibliog., ca. \$15.00.

INDUSTRIAL MANAGEMENT: EAST AND WEST. Edited by *Aubrey Silberston* and *Francis Seton*. Revised and extended papers from the 1971 Conference on Productivity at Ravello, organized by the International Economic Association, with contributions by experts from the Soviet Union, Eastern and Western Europe, and the U.S.A. July, 1973, 278 pp., tables, figures, ca. \$17.50.

MANUSCRIPT SUBMISSION

International Organization, the principal scholarly periodical in its field, publishes analytical articles, review essays of current literature in the field, brief notes dealing with problems of both theoretical and methodological interest, and comments designed to encourage lively interchanges of views on issues of wide interest, public policy, and previously published articles, review essays, notes, and comments.

Manuscripts submitted for publication should focus primarily on the development, functioning, or political factors associated with international agencies and regional arrangements, or on their dynamic relationships with the international political and economic environments in which they operate.

The Board of Editors welcomes fresh critical analyses along the foregoing lines. It is not interested in descriptions or chronological treatments of institutions with little assessment and interpretation. Manuscripts should provide original, insightful interpretations and evaluations of significant developments or trends; they should not repeat material familiar and elsewhere available to specialists in international affairs.

All manuscripts should be sent in triplicate to the Editor, David A. Kay, at the address below. Articles and review essays submitted for consideration should not exceed 35 double-spaced typewritten pages (8½" x 11"). Notes on theory and method and comments should not exceed 2,000 words. The style should be consistent with the University of Chicago **Manual of Style**.

Decisions on publication are made pursuant to independent critical comment by three or more competent readers including the Editor. Authors may expect a decision within six weeks of the Editor's receipt of a manuscript.
