## CLIPPING AND INDEXING SERVICE

Information Services on Latin America (ISLA) now offers a clipping and indexing service on Latin America. It provides a monthly air mail listing of the previous month's clippings on Latin American events from the weekly Le Monde English edition and seven major U.S. daily newspapers (The Cbristian Science Monitor, The Journal of Commerce, the Los Angeles Times, The Miami Herald, The New York Times, The Wall Street Journal, and The Washington Post). These clippings are organized by country and are reproduced on approximately 150 pages ( 300 sides). The service also provides an extensive semi-annual index, organized by country, foreign organization, and personal name.

The service gives comprehensive coverage of political, diplomatic and economic news, and editorials, and selective coverage of cultural, scientific, and social events, book reviews, and letters to the editor. ## INTER-AMERICAN UNIVERSITY OF PUERTO RICO PRESS

In 1970 the Inter-American University announced the establishment of a press which will publish a journal, monographs, and books. ## LATIN AMERICAN URBANIZATION

Scarecrow Press recently published a new combination bibliography-directory, Latin American Urbanization: A Guide to the Literature, Organizations and Personnel by Martin H. Sable, University of Wisconsin-Milwaukee. This all-in-one source book covers all fields of knowledge and activities with respect to Latin American cities.

The work is in three sections. Part I is a detailed bibliography of 7,000 books, pamphlets, periodical articles, conference proceedings, documents, and theses published world-wide. Parts II and III consist of directories of research centers, working organizations in urbanization and allied fields, and specialists in these fields.

## NATIONAL ATLAS OF CUBA

The new Atlas Nacional de Cuba (Natsionalnyi Atlas Kuby) has appeared through a cooperative effort of the Cuban and Soviet Institutes of Geography of the Academies of Sciences. The Cuban version of the atlas is in Spanish, while the Soviet version is in the Cyrillic alphabet. The atlas project was initiated in April 1965 by the Institute of Geography in Havana under the supervision of the chief editor and
president of the Academy of Sciences of Cuba, Antonio Nuñez Jimenez. The Cuban Institute of Geography directed and coordinated the research work of the 40 institutions participating in the preparation of the atlas. Soviet cartographers served as consultants in editorial and compilation work on the atlas.

The 144 -page volume includes 105 maps in color, 23 pages of text, and a sevenpage index of geographical names. The maps are divided into the following categories: general, physical, agricultural, industrial, cultural, historical, and population. Some maps also show the larger cities of Cuba. Approximately half of the maps deal with the natural features of the Cuban archipelago. Explanatory text accompanies each group of maps. The emphasis throughout the atlas is on the comparisons of preand post-revolutionary statistical data.

The atlas is priced at approximately $\$ 15$. The Joint Publications Research Service (JPRS) of the U.S. Department of Commerce has issued a complete translation of the National Atlas of Cuba. Copies of Translations on Latin America, No. 525, National Atlas of Cuba (JPRS 53167), May 19, 1971, may be ordered from the National Technical Information Service, Springfield, Virginia 22151 for $\$ 6$ each.

## THE WIND THAT SWEPT MEXICO

Originally published in 1943, and for some time a prized collector's item, The Wind that Swept Mexico has been reprinted by the University of Texas Press. The text written by Anita Brenner has been completely reset and the plates have been remade from exhibit prints furnished by the New York Public Library. No other changes from the original addition have been made. The exhibition copies of the 184 historical photographs originally assembled by George R. Leighton have been given to the Institute of Latin American Studies, University of Texas at Austin.

## LATIN AMERICAN URBAN RESEARCH

Sage Publications, Inc. announces a new series: Latin American Urban Research. Volume I (1971) focuses on urban migration and marginality, urban culture-values and norms, government institutions and decision-making, and policy problems. This first volume was edited by the series editors: Francine F. Rabinovitz and Felicity M. Trueblood. (See book listing on p. 164.) Volume II (1972) is devoted to "Regional and Urban Development Policies: A Latin American Perspective" and is edited by Jorge Hardoy and Guillermo Geisse. Volume III (1973) is tentatively planned to encompass a selection of papers on the politics of urbanization in Latin America.

A new volume will appear in late spring or summer of each year. ## NEW AND SUSPENDED PERIODICALS

The new Journal of Caribbean History is published in May and November each year by the Department of History, University of the West Indies. The first and

only issue of Volume I appeared in November 1970. The journal carries articles on aspects of Caribbean history, including the history of mainland territories in North, Central, and South America where it is related to the Caribbean, research notes, and book notices. The cost of an annual subscription is $\$ 3.60$ ( $£ 1.50$ ). Single issues can be purchased for $\$ 2.10$. The Center for Latin American Studies, University of Pittsburgh, in cooperation with the University Center for International Studies, has begun to publish the Cuban Studies Newsletter. The first issue of the Newsletter appeared late in 1970 and will be published twice a year. The publication provides a bibliography of books, pamphlets, articles, and book chapters on Cuba. Volume 1, No. 2 included a list of more than 100 periodicals published in Cuba during the period 1959-1970. Other sections contained information on statistical compilations published in Cuba and an international list of suppliers of Cuban research materials.
