Danielson studies subnational politics, migration, gender and social movements in the Americas.

Christine Di Stefano is Associate Professor of Political Science and Adjunct Associate Professor of Women Studies at the University of Washington, Seattle. Her previously published work includes Configurations of Masculinity: A Feminist Perspective on Modern Political Theory (Ithaca and London: Cornell University Press 1991) and Revisioning the Political: Feminist Reconstructions of Traditional Concepts in Western Political Theory, co-edited with Nancy J. Hirschmann (Boulder, CO: Westview Press 1996). Di Stefano is currently at work on a study of The Souls of Black Folk by W.E.B. Du

Bois as a contribution to the political theoretical literature on modernity and another project on the political thought of Alexandra Kollontai and the politics of love.

Amanda Driscoll is currently a PhD student in the Department of Political Science at Washington University in St. Louis and is a graduate student associate in the Center for Empirical Research in the Law in the Washington University School of Law. Her research focuses on Latin American political institutions, with an emphasis on electoral rules and inter-branch relations in comparative perspective.

Todd A. Eisenstadt is Associate Professor of Government in the School of Public Affairs at American University. He is the author of Courting Democracy in Mexico (Cambridge University Press 2004) and has authored and/or edited four other books. He has articles published or forthcoming in journals including Comparative Political Studies, Latin American Politics and Society, Democratization, Party Politics and the Latin American Research Review. A recipient of Fulbright and National Security Education Program "Boren" fellowships, his research has also been funded by Ford and Mellon foundations. Eisenstadt has been a visiting scholar at the El Colegio de México in Mexico City, Harvard University's David Rockefeller Center for Latin American Studies, the Japan Institute for International Affairs in Tokyo, and the University of California, San Diego's Center for US-Mexican Studies. Professor Eisenstadt studies democratization, identity and social movements, public opinion, political parties, and election finance, principally in Latin America. He is completing a manuscript, Surveying the Silence: Liberal and Communal Identities in Southern Mexico's Indigenous Rights Movement, based on a large survey he directed to compare indigenous and non-indigenous attitudes in southern Mexico.

Eileen Hunt Botting is the Thomas J. and Robert T. Rolfs Associate Professor of Political Science and the director of Gender Studies at the University of Notre Dame. She is the author of Family Feuds: Wollstonecraft, Burke, and Rousseau on the Transformation of the Family (SUNY, 2006) and co-editor, with Jill Locke, of Feminist Interpretations of Alexis de Tocqueville (Penn State 2008). She is co-editing, with Sarah L. Houser, the first edition of Hannah Mather Crocker's 1827 handwritten book manuscript, Reminiscences and Traditions of Boston (NEHGS Press).

Meryl Kenny is a doctoral candidate in the Politics and International Relations Department at the University of Edinburgh, Scotland. Her research interests include feminist and new institutional theory, political recruitment, political representation, and territorial politics.

Mona Lena Krook is Assistant Professor of Political Science and Women and Gender Studies at Washington University in St. Louis. She is a Fellow at the Radcliffe Institute for Advanced Study at Harvard University (2008–2009). She is the author of *Quotas for Women in Politics: Gender and Candidate Selection Reform Worldwide* and co-editor with Sarah Childs of *Women, Gender, and Politics: A Reader*, which will both be published by Oxford University Press in 2009.

Teresa Kulawik is Professor of Gender Studies at the Södertörn University of South Stockholm in Sweden. She received her PhD in Political Science at the Free University of Berlin in Germany in 1997. She published intensively on gender regimes and the welfare state in Sweden and Germany from both a historical and contemporary perspective. Her recent work investigates the relation between science, public knowledge and political processes, focusing on the implications of the live sciences for policy regulations and new forms of governance, so called soft governing through deliberations and ethics. She is participant researcher in the EU integrated project "FEMCIT: The Construction of Female Citizenship: The Impact of the New Women's Movements on Contemporary Gendered Citizenship."

Mary-Kate Lizotte is a doctoral candidate in the Department of Political Science at Stony Brook University, soon to be an Assistant Professor at Birmingham-Southern College. Lizotte has written and published papers on the role of gender in political behavior and is currently working on projects examining whether the gender gap in voting in presidential elections has been caused more by the movement of women towards Democratic candidates or men towards Republican candidates.

Joni Lovenduski is Anniversary Professor of Politics at Birkbeck College, University of London, European Convener of the RNGS project, and author of *Feminizing Politics* (Polity Press 2005). She is co-editor (with Claudie Baudino, Petra Meier, Marila Guadagnini and Diane Sainsbury) of *State Feminism and Political Representation* (Cambridge University Press, 2005). She works on political representation, political

parties, equality policy and gender. She was elected Fellow of the British Academy in 2006.

Fiona Mackay is Senior Lecturer in Politics at the University of Edinburgh, Scotland. She researches and writes on women's political representation, and gender and constitutional change in the United Kingdom. She founded and co-directs the new Feminism and Institutionalism International Network (www.femfiin.com). Publications include Love and Politics (2001); Women and Contemporary Scottish Politics (co-edited, 2001); The Changing Politics of Gender Equality in Britain (co-edited, 2002), and Women, Politics and Constitutional Change (co-authored, 2007).

Surya Monro is a researcher at the Department of Politics, University of Sheffield. Monro has a strong track record of research and publications in the fields of gender and sexuality, notably on the topics of transgender, lesbian and gay equalities in local governance, and sexual/gender citizenship. She is the author of *Gender Politics: Citizenship*, *Activism, and Sexual Diversity* (Pluto Press 2005). Monro is currently engaged in research about 1) sexual/gender minorities and equalities in local government, and 2) gender and ceremony in South African parliament (as part of a large cross-cultural study funded by Leverhulme).

Andrew H. Sidman is an Assistant Professor in the Department of Government at John Jay College of Criminal Justice, a senior college of the City University of New York. Sidman has presented papers on congressional elections, the federal pork barrel, and the roles of political knowledge and sophistication. He has published work on presidential elections and the effects of war on public evaluations.

Georgina Waylen is Professor of Politics at the University of Sheffield, United Kingdom. She has researched and published widely on gender and politics. She is the author of Gender and Politics in the Third World (1996) and Engendering Transitions (2007), which was co-recipient of the 2008 Victoria Schuck award; and she is the co-editor of Gender, Politics and the State (1998), Towards a Gendered Political Economy (2000) and Global Governance: Feminist Approaches (2008).

Priscilla Yamin is Assistant Professor of Political Science at the University of Oregon. Her work focuses on gender, race and American politics, with

interests in institutions and culture. Her current research focuses on the history of marriage as political institution in the United States. She has recently published an article in *Polity* on this topic. She is now completing a manuscript tentatively entitled, *Nuptial Nation: Marriage Politics in the US*.

MANUSCRIPT PREPARATION

- Manuscripts must be no longer than 30 pages including text, tables and figures, references and appendices. The entire manuscript (including notes and references) must be double-spaced, with one-inch margins and 12-point font, and printed on one side of the page only.
- The author must include a separate title page, with his or her full contact information (including email address, telephone number and institutional affiliation), and a brief biographical statement. All identifying information must be removed from the manuscript.
- A second page must include an abstract of no more than 200 words.
- Placement of tables or figures should be cited in the text. The publisher will be responsible for placing artwork, tables or figures, as well as converting endnotes to footnotes.
- Appendices, tables, and figures should be numbered consecutively throughout the article and be included on separate pages

- appearing after the reference section. Figures should be ready for photographic reproduction; they cannot be redrawn by the publisher. Charts, graphs, or other artwork should be professional rendered or computer generated. Photographs should be clearly printed and should remain legible after a 50% reduction.
- References and notes should conform to the APSA Style Manual. Authors should include full volume, issue, and page numbers for references. Author's acknowledgments or other personal notes will appear as an unnumbered note at the foot of the page. Notes should be numbered consecutively throughout the article. Numbered notes should appear at the end of the sentence. If multiple texts are cited in a sentence they should appear as one consolidated note at the end of the sentence.
- Endnotes should be employed (rather than footnotes).
- All figure captions should be typed on a separate page (or pages), rather than on the figures themselves (which are camera-ready art) so that they can be copyedited.

Originality and copyright: Papers with multiple authors are reviewed with the assumption that all authors concur with its submission. A Copyright Transfer Agreement, with certain specified rights reserved by the author, must be signed and returned to the Editor by senior authors of accepted manuscripts, prior to publication. *Politics & Gender* does not accept manuscripts for review that are under review elsewhere, previously published or already committed for publication.

For general guidelines for preparing a manuscript for submission, please refer to the *APSA Style Manual for Political Science* (rev. ed. 2001) for citation, footnotes, references, and other style issues. Please note, in particular, the statement on gender-specific language (15).
